There are a lot of fights in this section of Dyckman and it is hard to tell where the crowd is coming from specifically, but it appeared that there is always a crowd gathering in front of this establishment

The owner stated that he takes very seriously the violations stated by the 34th Precinct. The incident with an officer that was punched in the face is still under review with the SLA. Couples had a domestic dispute inside the restaurant and were asked to leave. After they left the fight continued right outside the establishment. This is when the officer got punched in the face while trying to break up the fight

Owner stated that the license and occupancy signs are posted but in an obscured location

The window covering with alcohol advertisements was another way to collect revenue from advertisers

Windows were covered with advertisements for a long time, it was not clear if this was a promotion or renovation at the location.

There are fights in front of the establishment and although they have good soundproofing, the venue is very loud when they open the retractable doors

They do not care about what happens when their patrons leave, no Good Neighbor sign is posted
