<u>Call To Order</u>: Chair Shah Ally called the meeting to order at 6:43 pm. Quorum is attained. Agenda adopted. Last month's minutes adopted.

**Chairman's Report:** Shah Ally's report covered the following topics:

- The City Planning Commission voted to approve the Inwood Rezoning plan.
- All new CB12 Board member appointments have been completed. The new board members were welcomed.
- The Committee of the Whole will meet on July 24.

**District Manager's Report**: Ebenezer Smith's report covered the following topics:

- At the monthly District Council meeting the first 2020 budget discussion with city agencies occurred.
- Ely Sylvestre just completed her first year in the CB12 office and is now off probation. Paola Garcia has completed 10 years working at CB12.
- Various event announcements.

## **Pubic Speakers Session:**

**Edith Prentiss** – She can support the Haven Plaza plan with certain changes. Especially supports moving the Greenmarket into the plaza.

**Eric Duran** – Is in favor of a plaza, but not on Haven Avenue. He listed a few other locations in the area where the plaza makes more sense.

**Heidy Hernandez** – Supports the Haven Avenue Plaza.

**Sandi Salavanti** – Spoke strongly against the Haven Avenue Plaza.

**Lisa Stepanian** – Stated that Columbia's level of trust with the community is a negative 5 on a scale of 1 to 10. She does not support the Haven Avenue Plaza. Will cause increased traffic and parking problems. Spoke strongly against low down tactics foisting the plaza on the community.

**Bob Ortiz** – Stated that the Haven Avenue Plaza will cause havoc on the community. How are the patients on dialysis going to get to their appointments? He is appalled at CB12 for the way they've turned away from the community.

**Phil Zablocki** – Strongly urged CB12 to vote no on the Plaza. Mentioned 1000 names on a petition against the Plaza. Parking spaces will be removed. Why not use the Armory instead of Haven Avenue for recreational space?

**Paul Hintersteiner** – The location of the Haven Avenue Plaza is too cold and windy to use as a public space. Stated that this plaza will not be viable.

Elivvette Caballero – Spoke in Spanish in support of the Haven Avenue Plaza.

**Pedro Valerio** – A local resident, he spoke in support of the plaza, because a place is needed to relax outdoors. It will be great to see a child running in the street.

**Rafael Figuereo** – Spoke about the impact of the plaza on the community. He supports the plaza and says we need a place where 200 children can congregate outside.

**Daniel Allalemdjian** – spoke in support of the plaza.

**Lenishemane Lopez** – She spoke against the Plaza. Also representing Growth and Development Services (GDS) which provides recreational programs for children in the summer.

**Dr Gary Altheim** – Castigates CB12 for hiding deals made with Columbia for this plaza, which he strongly opposes. Columbia has space in the Armory – why not use that?

**Emil Melban** – Suggests that we create programs for our youth. Instead of the Haven Avenue Plaza, let's use the Armory.

**George Jaramillo** – Feels that Columbia is all about real estate, not about public plazas or medical care. Columbia wants the space for its own use and wants the community out.

**Eva Hernandez** – There are already plenty of spaces for people to meet. Programming resources are what's missing. This Plaza is a complete abomination. Period. The children need love and support, through programming for them. The plaza is all about real estate, that's all.

**Michael Hano** – Provided a presentation showing the many parking spaces that Columbia is concealing and saving for their staff despite the creation of the plaza, which will take spaces away from the community.

**Brian Smith-Sweeney** – Spoke in favor of the Plaza.

**Ari Sherizen** – Spoke in favor of the plaza.

**Ysabel Abreu** – Spoke in favor of the plaza. A place where every one of all economic classes can meet. Open Spaces are critical for healthy activities. Let's have coffee with Columbia students in the Plaza.

**Zead Ramadan** – A former member and chair of the community board, he spoke about the political process and how to influence it. Recommends a yes vote with conditions.

**Balint Szent-Miklosy** – An architect, he knows the tricks of urban planning. He expects Columbia to use the Plaza as a wedge to knock down older buildings in the vicinity to create larger new ones, including on the plaza.

**Ray Rogers** – An activist From East Harlem, spoke strongly against the Plaza. He says that Columbia cannot dodge its history as a developer and agent of disruption. Columbia must be stopped.

**Matthew Rafferty** – He is strenuously opposed to what he called Columbia's land grab. Columbia is rapacious and dishonest.

Joel Yoffie – read a poem he calls "There is not time for reasons dream".

**Jeanne Ruskin** – She spoke on the Inwood Rezoning plan and asks CB12 board members to come to City Hall on 7/10 to the City Council hearing on the rezoning plan. Also lends support to opponents of Haven Plaza.

Natasha Arroyo – Spoke against the Arka sidewalk cafe. #14 on the licensing committee resolutions.

**Danita Nichols and Kassandra Innocent** - They offer gratitude for support of our local libraries. Then discussed and invited us to summer programs at the libraries.

**Katie Heim** – She spoke against the Arka sidewalk café proposal (Resolution #14). She lives across the street from the establishment and maintains that they cannot run a lawful safe place. Asks the Board not to allow them to open this café.

**Shira Dubin** – A 19 year old who lives near Arka Cafe. She states that Arka patrons harass women walking by. Shira's 16 year old sister is scared to walk alone near Arka. There are catcalls. There are threats. She asks us to please not allow Arka to open this sidewalk café.

**Sandra Luckow** – She strongly urges a yes vote to oppose the proposed Arka sidewalk café, listing many problems that the establishment already causes, like Illegal valet parking, overcrowding and harassment of women walking by. She is awakened by noise and fights on many nights. She told us that Arka claims that they do not control their patrons once they leave the establishment.

  discussion of the issue at hand, though all Board members were handed the resolution that explained
  the decision we needed to make. See below for more details.

**Resolution B** - Resolution Supporting The Land Use Review application submitted by ACS and DCAS to enter into a New Lease for The UFBCO Day Care Center at 474 W. 159th Street.

Executive Committee— Wayne Benjamin, Chair, Land Use begins the discussion:

- A new 20 year lease for this city run child care organization triggers a ULURP process.
- The community board has a role in every local ULURP, and so we are engaged here.
- The Land Use Committee supports the new lease, as does the capable staff of the UFBCO Day Care Center.

**Resolution C -** Resolution Supporting The M-1 Zone Hotel Text Amendment Proposed by The Department of City Planning.

Land Use Committee— Wayne Benjamin, Chair, Land Use begins the discussion:

- Many hotels are being built in New York City.
- Id this resolution is turned into law all new hotel development proposals for Light Manufacturing zones (M-1) would trigger a new special permit requirement to gain better control over use of this resource.

**Resolution D -** Resolution regarding a Pedestrian Plaza on Haven Avenue (btw. W. 169th & W. 168th Streets. Traffic & Transportation Committee- Deborah Nabavian, Chair begins the discussion:

- The form and details of the lengthy resolution are explained.
- There were 2 traffic studies conducted to consider how taking this part of Haven Avenue out of service will impact the community and how best to mitigate the problems that will arise.
- Ayisha Oglivie provided a video that shows the current congested state at the corner of West 169
   Street and Ft Washington Avenue, before it will get converted from a 3 way to a 4 way intersection (if the proposed plaza is built). Ayisha is strongly against the resolution.
- Richard Lewis asks for changes to the resolution to remove pejorative references to homeless people, and for adding an official advisory group to guide the life of the plaza to the proposal. The changes were accepted as friendly amendments.
- Barbara Frazier is concerned about Columbia's ability to generate revenue in the plaza. She would like to see any revenue generated be used for public benefit, like arts programs. She'd also like to see more details around providing replacement parking to the community.
- Wayne Benjamin asks what can be done to make the resolution's conditions enforceable. Will there be a written, signed document to force this issue? Shah Ally explains that the project is conditional and temporary. The Community Board will be brought back into plans for the permanent plaza.
- Bianca Guerrero asks whether the block of 116 Street between Broadway and Amsterdam began as a temporary plaza? She wonders if this is the template that Columbia is following to turn the Haven Avenue space into a private plaza.
- Tanya Bonner asks how much access will the community have? There are other examples of public space that is controlled by Columbia that is not always accessible by the public. Muscota Marsh is mentioned.
- Maria Luna points out that parking is a central issue here. She states that parking is not a right. Maria also asks for all meeting participants at all times to respect the meeting, all its participants and the community board.

- Steve Simon provides 5 corrections and improvements to the resolution. He also asks that a water main project nearby be completed before the plaza project begins. This is all accepted as a friendly amendment.
- Jim Berlin concludes by telling the meeting that everyone will be able to use the plaza at all times. It
  will be a public plaza. He exhorts the massed attendees to use the plaza while the plaza is a
  temporary construct.
