Minutes for April 3rd 2018

1. Welcome / Opening Remarks

Meeting called to order at 7:00PM by Dr. Jason E. Compton.

Dr. Jason E. Compton presided as Chair and Eleazer Bueno, Asst. Chair was taking minutes.

Public and Committee members were welcomed. There was a slight change to the order of the agenda items.

2. New Business

Vacancy Tax

The Vacancy tax was discussed as an issue gaining traction within the de Blasio administration. De Blasio seems in favor of penalizing landlords who leave the storefronts sitting empty. As he stated a few days prior, "I am very interested in fighting for a vacancy fee or a vacancy tax that would penalize landlords who leave their storefronts vacant for long periods of time in neighborhoods because they are looking for some top-dollar rent but they blight neighborhoods by doing it," he said on WNYC. "That is something we could get done through Albany."

There was a reminder that Manhattan Borough President Gale Brewer has already been pushing for such a tax since last year, when her office studied the entirety of Broadway and found 188 empty storefronts — with the most in Morningside Heights. She also supports a plan being considered by the City Council to require property owners with empty commercial spaces to register in an official database so the city can keep track of vacancies.

There were various issues that our board discussed including:

- The need to speak landlords within our community to obtain their perspective
- The possibility of a resolution in support of this issue

Communication of this Committee

The chair stressed the importance of establishing various lines of communication within our community. The idea was that we are currently working on various issues that are simultaneously being discussed in other forums. Four different organizations were identified and the chair, as well as co-chair, have decided to develop open lines of communication with these groups.

- Manhattan Borough President Gale Brewer (connecting us with other Community Boards)
- Chamber of Commerce (assessing their history and connections)
- CB12 Licensing Committee (giving assistance to local merchants)
- Inwood Merchant Association (assist in organizing local merchants)

As an update on the issue, the public was reminded that on March 22, 2018, Council Member Ydanis Rodriguez re-introduced the Small Business Jobs Survival Act of which Rodriguez was a co-prime sponsor in the previous session. This bill would establish conditions and requirements for commercial lease renewal negotiations, including requirements for lease renewal terms, arbitration-triggering conditions, limits on security deposits, and prohibitions on landlord retaliation.

Our committee will keep an eye on the act as we feel it could have a major impact on our community.
