Re: RESOLUTION: OPPOSING CHANGE IN SNAP BENEFIT REQURIEMENTS FOR "ABLE-BODIED ADULTS WITHOUT DEPENDENTS" (ABAWD)

Dear Secretary Perdue:

At the General Meeting on Tuesday, May 28, 2019, with a vote of 37 in favor, 1 opposed, 0 abstentions. Community Board 12 Manhattan, passed a resolution opposing the change in SNAP Benefit requirements for ABAWD because it will negatively impact CB12.

Whereas:

Federal law generally limits the amount of time an able-bodied adult without dependents (ABAWD) can receive Supplemental Nutrition Assistance Program (SNAP) benefits to 3 months in a 36-month period, unless the individual meets certain work requirements.

Whereas:

On the request of a State SNAP agency, the law gives the Department of Agriculture (the Department) the authority to temporarily waive the time limit in areas that have an unemployment rate of over 10 percent or a lack of sufficient jobs. The law provides State agencies with a limited number of percentage exemptions that can be used by States to extend SNAP eligibility for ABAWDs subject to the time limit. The Department proposes to amend the regulatory standards by which the Department evaluates State SNAP agency requests to waive the time limit and to end the unlimited carryover of ABAWD percentage exemptions.

Whereas:

An ABAWD is defined as a person between the ages of 18 and 49 who has no dependents and is not disabled. This by definition does not include people with mental health concerns, substance use issues, people struggling with homelessness and/or people who are complicated with childcare and transportation issues.

Whereas:

As of January 2019, about 1.6 million New York City residents received SNAP benefits to help low-income families and individuals. As of 2017, a total of 48,826 total SNAP recipients lived within the CB12M district, helping 32,439 households receive assistance

and accounting for 26% of the CB12M district.

Whereas:

About 750,000 people in the United States are at risk of losing their SNAP Benefits,

which creates more financial burden and distress to U.S. citizens.

Resolved:

The parameters of compliance are best understood and controlled by each state rather

than the federal government, thus CB12 opposes the change in SNAP Benefit

requirements for ABAWD because it will negatively impact CB12 and the state at large, by rendering marginalized people in our community to further be in financial distress.
