- -Danielle Jettoo CB: Transferring from a Train to a shuttle bus back to a train. From shuttle to train no transfer was provided. MTA should acknowledge and provide clearer representation.
 - Mary Anderson: To bring it up at the board committee meeting on Thursday.
- -Gerard: Do we have a forum on congestion pricing?
 - -Jim: State passed this we have missed our opportunity to have a public session on the topic.
- -Caroline O'Neill, Park Terrace West public topic MTA's Access-a-Ride: You call at least 1 day in advance to get a paratransit vehicle. If late they needed to notify you. Which ran late constantly. Two new advanced reservation programs were introduced in 2017 and allowed for quicker pick ups via green and yellow taxis with far less delays at half the cost. "e-hail on demand" lets Access-A-Ride users summon taxis or car services from an app, but was limited to first 1,200 riders, less than 1 percent of registered Access-A-Ride users. The other "advanced reservation e-hail" relies on phone and has proven limited and unreliable.
