Residents filed 9-1-1 and 3-1-1 complaints about noise already emitting from the establishment. The 33rd Precinct reported 6 noise complaints about this venue since September 2019; therefore, be it

Whereas, the venue operates with 8 employees, 14 tables 43 chairs and 18 bar stools, with a total maximum legal capacity of 74 persons. The establishment's hours of operation are 24 hours 7 days a week; and

Whereas, per the applicant, the establishment's Method of Operation includes DJ, recorded music, karaoke, live music: non-amplified guitar; and

Whereas, the proposed establishment is within 500ft of four (4) On-Premises Liquor license; and

Whereas, Reily and Angel Toribio are the new owners of this new establishment; and

Whereas, the 34th Precinct reported three 3-1-1 noise complaints calls up to date. In 2018, seven 3-1-1 noise complaints calls. The Precinct also reported a 9-1-1 call on 11/1/19 about a fight inside the location; two individuals were arrested for having a weapon on them. The owner indicated that people are coming to the restaurant when they are already drunk; and
