#### Chairman's Report - Richard Lewis' report covered the following topics:

- Spectrum has completed the installation of the high-speed connection for live streaming of CB 12 meetings at the CB 12 offices.
- DOITT has been involved in the upgrade of technology at CB 12 and is working with us to upgrade the web page layout and navigation to ensure a more interactive website.
- There will be a Public Hearing with the MTA/ NYCTA at Isabella Geriatric Center on Thursday,
   December 19<sup>th</sup> at 6:30 pm regarding the planned closure of the 191<sup>st</sup> Street subway elevators
- and their plan to provide alternate transportation during the one-year shut down. All are invited.
- He thanked Paola Garcia and Shinelle Paniagua for their excellent work they did during Ebenezer Smith's absence.
- He presented a special award of thanks to outgoing Traffic & Transportation Chair and CB 12-member, Nick Martinez, who will be leaving the Board due to a change in his work in commercial real estate which will preclude attendance at CB 12 meetings. Nick thanked the Board for the opportunity he has had to serve the community.

- The Manhattan Complete Count Committee's Regional Director met with the MBPO's office on December 16<sup>th</sup>. The Census Bureau is looking to hire 180,000 census workers to complete the 2020 census, 80,000 of whom will be needed in NYC. The term is from January to June.
- The MBPO's office is hosting its Annual Baby Diaper Drive from now through January in coordination with the Food Bank of NY. Drop off is at the MBPO's northern Manhattan Office at 431 West 125<sup>th</sup> Street.

## Debbie Nabavian (Constituent Liaison), Office of Congressman Adriano Espaillat:

- Congressman Espaillat's legislative accomplishments in 2019 are outlined in a summary that is available on the table in the back.
- The Congressman is delighted to announce several priorities from District 13 that made it into the Federal Appropriations bill:

- o \$21M to body cameras for border agents;
- o \$45M for Hispanic college and university to expand STEM programs;
- o Funding for fresh foods nutrition programs;
- An increase in Capital Grant to cover the expansion of the 2nd Ave. subway
- Spoke about the constituent issues that are brought to the 181<sup>st</sup> Street office particularly as they relate to health care and the elderly.

## Orlando Ovalles (Chief or Staff) for NYS Assemblywoman Carmen De La Rosa:

The Assemblywoman has a summary of year end results in the latest newsletter including the following:

- The Greenlight Law passed permitting undocumented individuals to be able to get drivers' licenses.
- She co-hosted an information session with Dr. Guillermo Linares, President of HESC, on the Dream Act.
- She participated in a panel discussion with We Act on the toxins in cosmetics. and will introduce legislation accordingly.
- She participated in a Town Hall regarding the crisis at NYCHA.
- She will be represented at the upcoming Public Hearing on the closing of the 191<sup>st</sup> Street subway elevators.

#### Senator Robert Jackson

- Talked about the importance of today's vote on the Executive Committee composition.
- Last Monday/Tuesday, the Senate Democrats held a retreat where they were briefed in all of the subject areas that affect New Yorkers (Reforms, Issues, etc.), but the goal is to deal with the deficit of \$6 Billion.
- Spoke about the law suit that deemed that the NYC school system has been shortchanged in terms of state funding.
- Broke-down political composition of the Legislature and discussed the opportunity to elect 45
   Democrats to the Senate and ensure a veto-proof majority.
- Spoke about the make-up of his district and the need for re-districting in 2020.
- He will attend the Governor's State of the District address in Albany
- Encouraged attendance at the December 19<sup>th</sup> Public Hearing at Isabella

#### Councilman Ydanis Rodriguez spoke about the following:

- Promoted his Holiday Party here, scheduled for December 21<sup>st</sup> at 530 West 166<sup>th</sup> Street on the 2<sup>nd</sup> floor.
- Announced a bill he's sponsoring permitting those who have a green card to be able to vote in municipal elections.
- He has secured \$60M to renovate GW High School including \$22M for the pool.
- December is the deadline to whoever wanted to respond to lead the Immigrant Research Center for the Performing Arts
- Elizabeth Lorris Ritter rose to a point of personal privilege and requested an apology from Councilman Rodriguez claiming the Councilman had said that Ms. Ritter lied in saying that the he did not want her to be elected as Board Secretary. The Councilman denied making any statement to that effect and offered no apology.

# Maria De La Cruz, Liaison, Office of Comptroller Scott Stringer reported the following:

- The Comptroller's office has issued many reports in the past several weeks and they can be found on the Comptroller's web site.
- One of the reports concerns the Rain Gardens. DEP is supposed to maintain the Gardens but has not been maintaining the maintenance logs in an accurate and up-to-date manner.
