The guard walked out of his post and the man walked in unchecked. The individual walks in to the mandatory coat check area, gave the attendant money but retained his coat. Another security guard says that he did not get searched, he then approach the patron, reached to the hood of the patron's coat and pulled out a loaded firearm. The patron left, and the police were called. The metal detector at the location only scans from the waste up and the firearm was never detected before the patron entered the venue A few days after the 12/27/19 incident, the operator watched images from the security cameras and found images of a security guard receiving money to allow minors in for a drink

1/4/20 fight 3 people got arrested for disorderly conduct, the location was heavily overcrowded with about 133 people. Only 74 persons are allowed since their PA license expired 1/7/20 joint inspection with SLA & DOH. SLA observed 10 various violations; failure to post occupancy signs, alcohol from unauthorized source, cook was drinking for himself, premixing alcohol, fire extinguisher wasn't inspected. Misleading information to the SLA: Operating with DJ although not in their method of operation The 34th Precinct cannot support this application in an already problematic establishment Owner reply: The new owner does not have much experience but her uncle passed away and Margio Oleaga will be managing the establishment until an experienced manager is hired.
