Re: Resolution Proposing Bus Service for A-Train Stations at 184th and 190th Street Stations

Dear President Andy Byford and Chairman Ferrer:

At the General Meeting, Tuesday, June 25, 2019, Community Board 12 Manhattan, passed the following resolution with a vote of 38 in favor, 0 opposed, 1 abstention, requests that scheduled shuttle service be provided for those needing it to travel between the current entrances of the elevator system linking the two levels of our vertically separated communities for the entire time that the elevators are not available during the proposed MTA elevator rehabilitation project.

Whereas: The elevator connections between Overlook Terrace and Fort Washington Avenue at 184th St. provided by the MTA have been community amenity for numerous decades thanks to the efforts of the late State Senator Joe Zaretski, and other visionary elected officials of the time, and.

Whereas: This special vertical link has engendered and forged several communities with members both above and below the massive cliff that would otherwise separate them, and,

Whereas: These groups include senior citizens, the disabled, families many with young children, and others who under their circumstances would find ascending and descending this historic cliff otherwise impossible, and,

Whereas: This same cliff was sufficiently formidable that it comprised much of the eastern defense of Fort Washington, which is now within the area of Bennett Park, and,

Whereas: All of these communities will have their activities disrupted, if not entirely quashed, but the impending simultaneous closing for the repair of all of the elevators at this 181st St. A train station, and,
