Meeting called to order at 10:30 AM by Mary Anderson, Chair. Welcome extended to all. Introductions made.

- (1) Presentation made by NCOs (Neighborhood Coordination Officers) and other members of the NYPD 34th Precinct. The NCO's are community police in the area. The precincts are divided into 4 Sectors: A, B, C and D. Each Sector has 2 NCO's assigned to the area The purpose is for more immediate problem solving as the NCO's get to know the area and the residents and businesses in the area. Meetings are held 3 to 4 times a year for each Sector with the community to provide a forum for increased dialogue between community members and the NCO's. Crime Prevention Officer Richard Natal lead a discussion about "what is abuse" not just physical; not allowing access to phone, ID or any other kind of intimidation. Current common crimes include package theft: deterrents include planning to be home for delivery, asking a neighbor to accept the packages; and burglary through unlocked windows, especially fire escape windows. Haydee Pabey reinforced the accessibility of the NCOs to the community.
- **(2) Presentation** by Giovanni Feliciano of Parks Open House at Highbridge Recreation Center a week long program from 9:30 AM to 9 PM. Reminder that seniors over 65 with ID can attend this event free.
- . (3) Deborah Gross, Director of Hudson Community Safe at Home project at the Y gave a description of the program for those above Medicaid eligible and unable to pay or access

services. Includes casework, nurse practitioner, nutritionist, and housekeeping at \$14 per hour, food pantry, and car service at \$2 each way. OT students provide home safety assessments.

- **(4)** Meliisa Abreu presented Memory Center program at Riverstone Senior Life Services. There is a Social Adult Day Center and a Caregiver program in support of those who care for others.
- **(5) Next meeting** will be 3/7/19 at 9:30 AM at Isabella Geriatric Center. Meeting adjourned at 11:45 AM.
