

Discussion on the Mayor's Proposed Zoning Text Amendments (MIH&ZQA)

- Discussed the special Manhattan Borough Board meeting remarks by Manhattan Borough President Gale Brewer and other community board chairs or their representatives.
- Discussed the mandatory inclusionary housing (MIH) and the Manhattan Borough Board resolution recommending conditional disapproval of an application by the Department of City Planning.
- Discussed feedback on the zoning for quality and affordability (ZQA) by the Manhattan Borough Board. The resolution recommends the conditional disapproval of an application by the department of city planning to create a mandatory inclusionary housing program.
- Richard Lewis compiled a progressive list of news articles and reports in date order showing the sequence of
 events of all NYC boroughs' board rejections of the MIH/ZQA proposals (available upon request from the board
 office).
- Discuss the ZQA/MIH letter written by Borough President Gale Brewer and City council members of Manhattan to the City Planning Commission chair, Carl Weisbrodt, dated November 17, 2015.
- December 16, there will be a public hearing at the DCP regarding the MIH text amendments??
- 421a June 15th, 2015 new law needs to be agreed by developers and the unions by January 15th, 2016 or it sunsets.
- Barbara Frazier discussed that the Board of Standards and Appeals loophole in the zoning text resolutions must
 be tightened so that it will be only used in the presence in real hardship and not as a path of least resistance for
 developers who do not wish to build affordable housing.
