6:45pm **Adoption of the agenda**: Motion by Gerard Dengel, second by Mary Anderson. Elizabeth Lorris Ritter moved to add a resolution by the Executive Committee inadvertently omitted from the agenda. No objections; the agenda was approved without additional changes and with no objections.

6:47pm Introductory remarks by Shahabuddeen Ally, Chair

- Thanks to CU for hosting our meeting in their excellent new space in this new, LEED-certified building.
- Ross Frommer, CU's Deputy VP for Government & Community Relations made brief comments regarding the new (opened a year-an-a-half ago) building, and what it means to medical education. He presented her with a Certificate of Achievement; Ms. Saneux came up with her family and made brief remarks.

Phil Simpson: Inwood is facing a severe existential crisis. Please support the Exec Com reso re EIS work scope.

Katherine O'Sullivan, Moving Forward/Unidos: Oppose Licensing #16 (Playroom), #20 (Kon'to), & #26 (Casa de Mofong); support Executive Committee reso re Inwood rezoning EIS work scope.

Bennett Melzack: support Executive Committee reso re Inwood rezoning EIS work scope. Be concerned for how your neighbors are living, and what the future holds.

Jeanne Ruskin: cited a children's book about a turtle and a pond and a builder and a little boy by way of introducing a metaphor on development and urging the Board to support Exec reso re Inwood rezoning EIS work scope.

Valinn Ranelli, spoke in opposition to rezoning and in favor of Exec Committee reso re Inwood rezoning EIS work scope.

7:55pm Ydanis Rodriguez, Councilmember, NYC Council 10th District

- In 8 years I have not supported a single spot-rezoning. He enumerated several proposals he has opposed, in order to maintain the current landscape. I believe we will end in a better place if there's a plan on the table to discuss, not just to oppose everything. Don't lie. Be accurate. Be specific. This plan has an interim library and the new one will provide many services that we need. It will provide many services that we need: affordable housing; an immigrant cultural center, a theatre. We need these things. I invite people to come talk to me. My main focus is east of Tenth Ave., which is undeveloped. We will protect the Broadway corridor, Post, Sherman, and the residential core. We can build a legacy together.
- Today I was proud to co-sponsor a bill to ban hookah in restaurants. 40mg hookah = 120 cigarettes. If you want to open a hookah bar, fine. But not to add to clubs and bars. A place with hookah will need to get at least 50% of its revenue from hookah. We are following the examples of Toronto, LA, and the Dominican Republic.
- All are invited to my State of the District address on Sunday, October 15th, at the Salome Ureña School / IS218 Auditorium; doors open at 1pm.
- I support Casa de Mofongo, and urge you to vote in favor of their application.

- Maria Gonzalez, Citizens Committee for New York: announced two grant programs for small community-based organizations to get funding for projects and programs. Small grants, up to \$3k; deadline is 1/22/18. Love Your Block Grants for beautification (up to \$1k); deadline is 11/6/17. For more information, visit www.citizensnyc.org.
- Joel Yoffie: read a poem that slandered a local non-profit and made unsubstantiated allegations of anti-semitism.
- **Michelle Kohut** Presented 4,717 signatures on a petition to "Save Inwood Library", including commentary by on-line signatories. We are organized. We are powerful. We will fight to have full, uninterrupted library services.
- **Karla Fisk:** Save Inwood Library. The EDC draft work scope doesn't include a temporary library. Developers are not so generous to build something that they are not required to build.
- **Bob Barnett, Harlem River Community Rowing**: The River is a wonderful but underutilized resource. Our programming is free. We want to rebuild a rowing community in Inwood, including more free learn-to-row classes, which were all filled to capacity this summer.
- **Jessica Morris, Harlem River Community Rowing:** Active participant in CB11. Working to establish resources to provide additional waterfront programming. Spoke of the many benefits of rowing: physical, social, academic.
- **Catarina Rivera, WH/I Food Council:** Developing pathways to food justice. Announced upcoming meeting (9/28 at 7pm) and gave social media contacts. This will be a planning meeting for what to do in the coming year. Working with the Business Development Committee on legislation for food justice.
- **Shalim Lopez, Riverstone Senior Center:** spoke about their programs for caregivers for dementia patients, which offer both respite and support. All programs are free.
- Marshall Douglass, WH/I Land Trust: working on a plan to better use vacant land parcels uptown. Spoke in support of Executive Committee reso on Inwood rezoning EIS work scope.
- Maria Luisa Tassayco: WH resident, living on Pinehurst Ave. Spoke in support of Executive Committee reso on Inwood rezoning EIS work scope. Even though I do not live in Inwood, we should all care about this. I understand if the temporary library isn't in EDC's RFP if it is the NYPL's responsibility not the developer's/ But if it isn't in a legal document, how do we make legally binding NYPL's statement that they will build a temporary library?
- Chris Nickel: Spoke in support of Executive Committee reso on Inwood rezoning EIS work scope.
- Cheryl Miller, Moving Forward/Unidos: Spoke against Licensing reso #20 (unenclosed sidewalk café for Kon'to).
- **Gabriela Bill:** spoke against Inwood rezoning, which will displace people. Also, CB12 should do a better job notifying people who live east of Broadway about its, meetings and about the rezoning and the meetings to discuss it.
- **Lisa Whitten:** NYC teacher &CB12M resident. Spoke in support of Licensing item #16, an increase of space, which they use for exercise calluses, kids programming, etc., during the day. There is no alcohol at those events. We just want the space for these programs. (Note: This speaker spoke at 9:02pm, after it was realized that she had signed up on the wrong list and inadvertently had been passed over to speak during the Public Speakers' Session. Her remarks are recorded here as they are considered as part of that portion of the meeting.)
