- Introduction of members
- Ayisha gave a welcome statement and went over the agenda

NORTHERN MANHATTAN COMMUNITY LAND TRUST WORKING GROUP

- Floor was given to Paul Epstein (member of the Northern Manhattan Community Land Trust Working Group)
- Paul Epstein provided handouts to everyone and started his presentation
- Paul Epstein started presentation on Community Land Trusts (CTLs)
- Paul Epstein informed everyone to visit nyccli.org for more information on CTLs
- Barbara communicate to Paul the variety of workshops provided by Gale Brewers' office
- Ayisha explained why it is important for the community to embrace CLTs
- Paul answered questions asked committee members
- Barbara suggested Paul that his group should also focuses on cooperative housing and promote home ownership
- Member of EDC (Charlie Samboy) was present and commented that EDC currently does not have a position on CLTs

INWOOD REZONING - EDC SCOPE OF WORK FOR THE ENVIRONMENTAL IMPACT STATEMENT

- Barbara emphasized that we will be reviewing items of the EDC scope of work that touch housing and human services
- Discussion surfaced regarding the boundaries on Inwood
- "EDC doesn't disagree that areas below Dyckman belong to Inwood" Charlie Samboy
- EDC has no position on expanding the current proposal
- The current zoning proposal currently analyzes the environmental impact and it is not the final proposal that could be submitted Charlie Samboy
- Charlie Samboy suggested everyone to submit questions via e-mail (csamboy@edc.nyc)
- Conversation surfaced regarding traffic and the example of Nagle / 207th intersection was made by Fern
- Charlie suggested everyone to submit question as to how studies are being made
- Charlie explained the 19 categories of impact
- (comments about the EDC were being loaded on the computer screen)
- Member of the public Walter South provided handouts for an online class called "Creating affordable housing in your community" which will be offered online and in-person for more information you can reach him via e-mail (south@nyc.rr.com)
- (comments about the EDC were loaded on computer screen)
- Ayisha displayed the comments submitted by "Unified Inwood" so we could review them and see what the community has voiced
- Important points from their comments that were discussed:
- MIH results in displacement
- High-rises shouldn't be built in "potential flood zones"
- Impact of climate change
- Sustainable improvements utilization of CTLs
- Transportation Impact
- Homelessness concern
- Rent burden
- Document from "Unified Inwood" is available on the "Inwood Preservation" Facebook page
- We also reviewed the "State of New York Housing and Neighborhood Washington Heights and Inwood) by the NYU Furman Center (available on **coredata.nyc**)
- Median rent Burden: 32.5% (2015)
- Severely rent-burdened households: 31.8%
- Severely rent-burdened households, low income: 45.7%
- Comment was made by member of the public regarding Senior citizens housing (SCRIE) being removed by the rezoning
- Discussion surfaced on the topic of the vacancy rate ranking and noise ranking
- Noise pollution study question was asked by member of the public
- We reviewed the impact categories of the proposal to ma sure we cover items that relate to housing and human services
- Ariel commented regarding hazardous materials affected water provided to apartments and schools
- We discussed the land marking of historical locations to make sure they are preserved
- While discussing the impact of human services we talked about having adequate numbers of shelters, clinics and hospitals
