34th Precinct

May 2017 LC meeting: the Precinct was very happy to meet with the owner after many months of discussion but they would like to know who is the silent owner. The back rent is a concern and needs to be paid no matter what because soon enough there will be issues with illegal capacity to make up for the revenue lost while under construction

The main issue still exists; with so many people leaving area establishments at the same time the crowd is becoming unmanageable (parking, drunk patrons, flights, etc.). Even if the venue closes at 2AM, adding another 200-300 people to those looking to go to surrounding venues poses an additional safety issue. The 34th Precinct cannot support this application.

From April 2017 LC meeting: The Precinct did not change its position on this venue due to its high occupancy of about 300 people in a congested location. The previous establishment (Cliff) wasn't operating for long. There is court litigation against the previous owners and landlord. Based on current information we cannot change our position about this establishment.

Because of the traffic congestion coming from 202nd street, the Precinct is forced to shut down 202nd & 204th Streets due to the volume of valet and double-parking on the street, so that people can walk safely. Sherman Street is shut down from time to time to assist with traffic coming out of Fantastic. The 34th also deploys cars to the Dyckman Strip in the summertime and deploys traffic units to assist in directing traffic.

The 34th stated that to operate this large a venue the establishment would need to employ 20 security guards to deal with the anticipated volume. It reinforces that the 34th Precinct is concerned about the number of people exiting the establishment at 4AM. The precinct is requesting additional manpower and overtime to deal with the amount of people leaving these establishments. There are too many illegal incidents in this area and more enforcement is required.

The 34th Precinct is planning to take aerial photos and look at pedestrian congestion as people exit the clubs on 10th Ave. so they can bring the case to the Borough and request additional manpower.

- Tenants on 204th and 205th streets are concerned about the number of clubs already in the area and problems with patron's behavior (public urination, sex in the streets, littering, noise, music, DWI) when everyone leaves at 4AM. Complaints filed with the 34th
- A meeting between the 34th and residents in the area was planned for April 19th to discuss these concerns
- Moving Forward Unidos: Deputy Commissioner denied the application at the 500 ft. hearing and is now waiting for a CB12 resolution on this application. The report stated that the applicant was not prepared and the SLA denied the application but the agency is waiting for CB12 resolution
