Re: Overnight Closure of Tunnel Street for Filming of "In The Heights"

Dear Commissioner Trottenberg:

At the General Meeting on Tuesday, May 28, 2019, with a vote of 36 in favor, 1 opposed, 1 abstentions, Community Board 12 Manhattan, passed a resolution supporting the proposed overnight closure of Tunnel Street for filming, with the exception of encouraging WB to do it on a weeknight rather than on a Friday night.

Whereas: Warner Bros. will be filming "In The Heights," the movie version of Lin-Manuel Miranda's smash Broadway hit, largely on-location in Washington Heights this summer, featuring the neighborhood itself as an important character of the film; and

Whereas: One of the scenes will be filmed in Tunnel Street, the iconic graffitied tunnel connecting Broadway to the 191 1-train entrance at St. Nicholas Ave. and the creative team would like full control of the site during filming, and proposes a one-time overnight (10pm – 6am) shut-down of Tunnel Street on a Friday night; and

Whereas: Warner Bros. will provide a free shuttle between Broadway/St. Nick for MTA passengers and any pedestrian needing to traverse the tunnel; and

Whereas:

Representatives of the location company for Warner Bros. came to the Community Board 12. Manhattan Traffic & Transportation Committee on May 6, 2019, and to the Parks & Cultural Affairs Committee on May 14, 2019, and gave a complete and detailed proposal for their filming locations throughout the community during the period of (approximately) June 3rd through mid-July, including many strategies to lessen the impact of their on-location filming, and many community concessions and give-backs; and

night.
