Re: Calling upon Amtrak to remove the billboard structure at Riverside Drive and West 155th Street

Dear Senator Charles Schumer, Senator Kirsten Gillibrand, Congressman Adriano Espaillat, and President Richard Anderson:

At the General Meeting on Tuesday, March 26, 2019, Community Board 12 Manhattan, passed the following resolution with a vote of 37 in favor, 0 opposed, 1 abstention, calling upon Amtrak to remove the billboard structure it recently and partially installed at Riverside Drive and West 155th Street forthwith and not to place any other billboards in our community district at any point in the future and calling upon Senators Charles Schumer and Kirsten Gillibrand, Congressman Adriano Espaillat, and our other local elected officials to join Council Member Mark Levine in calling upon Amtrak to remove the billboard entirely.

Whereas: Amtrak has erected a large billboard structure in its right-of-way between the Henry Hudson Parkway and Riverside Drive at West 155th Street, alongside a residential area designated as the Audubon Park Historic District; and

Whereas: The structure will apparently hold two billboard signs facing northbound and southbound traffic on the highway; and

Whereas: These large signs, situated across the street from the site of John James Audubon's home in the 1800s, will detract from the historical character of this community; and

Whereas: These signs will have a further negative environmental impact by interfering with residents' and visitors' views of Riverside and Fort Washington Parks, the Hudson River and the Palisades, and by emitting light pollution that will affect residents' peaceful enjoyment of their homes; and

Whereas: These signs also will be a traffic safety hazard by distracting drivers on both the northbound and southbound lanes of the Henry Hudson Parkway, as well as on Riverside Drive, in an area that has experienced several accidents in the past; and

Whereas: Installing these signs close to the Henry Hudson Parkway violates the spirit of the federal Highway Beautification Act; and

Whereas: Amtrak told Council Member Mark Levine that it would lower the billboard by two feet; he deemed that response to the community's concerns to be insufficient and held a press conference last week calling upon Amtrak to remove the billboard entirely; and

Whereas: Pressure from State and City officials and the community succeeded in getting Amtrak's predecessor, Conrail, to remove a similar billboard structure along the same right-of-way in the 1980s; and

Whereas: Community Board 12-Manhattan passed a resolution at that time denouncing the billboard as a "deplorable condition," a characterization that applies in the current case as well; now, therefore, be it

Resolved: Community Board 12-Manhattan calls upon Amtrak to remove the billboard structure it has installed at Riverside Drive and West 155th Street forthwith and not to place any other billboards in our community at any point in the future; and be it further
