May 3 – 4 ECS/Verizon utility work (crew will be working around-the-clock until work is completed)  
Location: Intersection of 4<sup>th</sup> Avenue & E. 8<sup>th</sup>

**Monday, May 05 – Friday, May 09, 2014:**

- Operation #1** Continue demolition & relocation of ECS manhole  
Location #1 4 Avenue between E 8<sup>th</sup> & E 9 Streets
- Operation #2** Excavation of existing sidewalks (Elevated Noise Levels)  
Location #2 E. 4<sup>th</sup> Street from Broadway to Bowery
- Operation #3** Installation of new pigmented sidewalks  
Location #3 E. 4<sup>th</sup> Street from Broadway to Bowery
- Operation #4** Continue excavations/demolition of Peter Cooper Park  
Location #4 Cooper Square between E. 6<sup>th</sup> & E. 7<sup>th</sup>
- Operation #5** Intermittent Street closures during certain operations  
Location #5 various locations
- Operation #6** Rodent control operations  
Location #6 Peter Cooper Triangle/Cooper Square/within project limits

**Community Impacts:**

- Pedestrian access will be protected and maintained at all times.
- Emergency Vehicle access will be maintained at all times.
- During certain operations, vehicular access/partial street & lane closures may need to be temporarily restricted in order to facilitate construction. (Flag person will aid in facilitating vehicles)
- Dust, noise and heavy equipment are common elements of construction and we ask for your patience during the project.

- If an operation was not started and/or completed in the previous week, it will remain on the schedule until completed.
- Please Follow all Posted Pedestrian Detour & Construction Signage!
- Pedestrians are urged to exercise extreme caution when in the construction area and use an alternate route when possible.
