Operation #1 Location #1	Continue ECS utility work 4 Avenue between E 8 th ST. & E 9 ST.
Operation #2 Location #2	Catch basin chute connections E. 6 th Street and Third Avenue
Operation 3 Location #3	Replacement of Fire Hydrant E. 6 th and Third Avenue
Operation #4 Location #4	Rebuilding Con-Ed manhole E. 6 th and Third Avenue
Operation #5 Location #5	Backfilling trench E. 6 th and Third Avenue
Operation #6 Location #6	Continue roadway saw cutting (Elevated noise levels) various locations
Operation #7 Location #7	Performing Test Pit excavations (Elevated noise levels) Cooper Square West between E. 6 th & E. 7 th Streets
Operation #8 Location #8	Intermittent Street closures during certain operations various locations
Operation #9 Location #9	Weekly rodent control operations continue Peter Cooper Triangle

Community Impacts:

- Pedestrian access will be protected and maintained at all times.
- Emergency Vehicle access will be maintained at all times.
- During certain operations, vehicular access/partial street & lane closures may need to be temporarily restricted in order to facilitate construction. (Flag person will aid in facilitating vehicles)
- Dust, noise and heavy equipment are common elements of construction and we ask for your patience during the project.
- Contractor will employ all available noise mitigation techniques, certain operations will entail elevated levels of noise; DDC will monitor operations to assure that they are within DEP Noise Code Regulations.

Please Note:

- If an operation was not started and/or completed in the previous week, it will remain on the schedule until completed.
- Please Follow all Posted Pedestrian Detour & Construction Signage!
- Pedestrians are urged to exercise extreme caution when in the construction area and use an alternate route when possible.

Due to unforeseen conditions (weather, field conditions, etc.) it may become necessary to change some scheduled work locations and operations.
