The FY 2017 Preliminary Mayor's Management Report states that the number of violations issued for dirty sidewalks continues to increase compared to earlier years. The 4-month actual number of such violations increased nearly ten percent in FY 2017 compared to FY 2016. Last year, DSNY stated that complaints about sidewalk cleanliness are usually among the most frequently received and attributed the increase in violations to assigning more supervisors to focus on sidewalk cleaning issues. How are resources allocated to address these complaints and do you anticipate an increase or decrease in FY 2018 and FY 2019?

Every community board has at least one (1) agent assigned daily to patrol for all sanitation violations.

In the community boards with complaints on overflowing litter baskets, litter conditions, etc., the number of agents can be increased as needed.

See attached statistics on building enrollment into nyc organics collection for Manhattan to date. This includes partnerships that we have developed not only with residential buildings, but also some institutional sites, such as shelters (e.g. NYC Rescue Mission on Lafayette Ave). We have been and will continue to reach out to community boards, and local civic organizations, block groups, any group that might assist us to promote organics enrollment of residential buildings and institutional buildings. For buildings that are less than 10 units, we are working to enroll multiple neighboring buildings (e.g. a row of townhouses) at the same time to add efficiencies to our routes. All Manhattan public schools receive organics collection. Funding for Manhattan building recruitment is part of our overall outreach funding budget for NYC Organics citywide.

We have continued to expand the Organics program thru NYCGrow and Greenmarkets.
