All mechanical brooms are accompanied by a supervisor for a portion of their shift. There are no mechanical brooms with dedicated supervisor coverage.

There are currently 694 adopt-a-baskets in Manhattan.

We actively continue to work with businesses to seek out and engage new partners in an effort to continue to expand this program.

### **AGENDA ITEM 6 : Illegal Posting Violations**

The FY 2019 Preliminary Mayor's Management Report, DSNY noted that violations issued for illegal posting decreased significantly due to a policy change to issue a warning letter rather than a summons.

1. Has this resulted in a reallocation of enforcement agents to address other priorities?

2. Can you tell us how many warning letters were issued in Manhattan?

3. Has DSNY been able to quantify if the new policy has resulted in fewer illegal postings?

### **AGENCY RESPONSE:**

The FY 2019 Preliminary Mayor's Management Report, DSNY noted that violations issued for illegal posting decreased significantly due to a policy change to issue a warning letter rather than a summons.

1. Has this resulted in a reallocation of enforcement agents to address other priorities? COMMUNITY AFFAIRS

In March 2015, the Department of Sanitation received an adverse New York State Supreme Court decision which required the Department to reconsider its enforcement practices for poster law violations. The decision held that the issuance of multiple poster law violations can be a violation of the Eighth Amendment of the United States Constitution as an unconstitutionally excessive fine. In order to comply with this decision, the Department then instituted a policy of sending a warning letter to parties responsible for illegal posting, giving such parties two weeks to remove any posters that are illegally posted. If, after the two-week period, the Department sees the posters illegally posted (or stickers illegally posted on private property), the Department will then issue a violation for every illegal posting where a responsible party can be identified.

No, Illegal posting is still a priority in New York City. The only change is in the process to write these summonses.

2. Can you tell us how many warning letters were issued in Manhattan?

CY 2018 = 137 CY 2019 Jan- June = 118 Note: The numbers are based on the companies that were sent letters, not the amount of posters found. 3. Has DSNY been able to quantify if the new policy has resulted in fewer illegal postings?

No, the new policy has not deterred the public from posting illegally.

Compliance with public recycling baskets remains a concern. Contamination is an ongoing issue with publicly sited recycling bins. Unfortunately, there is no good remedy for this beyond public education as we cannot supply the resources to monitor the bins.

2. What is the funding for FY 2020 and will funding change in FY 2021? DSNY currently has \$111m funded in FY'20 for snow. The budget for FY'21 will be adjusted based on the 5-year moving average requirement once the final figures for FY'19 are available.

There were 324 Snow Laborers registered in FY19. Manhattan did not require the service of any snow laborers in FY19.

## **AGENDA ITEM 10 : Collection NYC Organics**

Please update us on the status of the NYC Organics Collection program in Manhattan, including partnerships with other agencies to advance the program.

1. Has the enrollment of residential and institutional buildings in the organics collection program grown since last year?

2. Will funding increase in FY 2020 and do you anticipate funding changes in FY 2021?

#### **AGENCY RESPONSE:**

1. Has the enrollment of residential and institutional buildings in the organics collection program grown since last year?

In Manhattan to date, 1,189 residential buildings (84,120 households), 80 institutional buildings, and 410 schools receive DSNY curbside composting service. Every month we are enrolling additional buildings, and we continue to recruit additional partners to host public drop off sites. At present, there are a total of 78 food scrap drop off sites in Manhattan, including 40 funded by DSNY and 38 hosted by community partners. See locations on our map at nyc.gov/dropfoodscraps

In January 2019, City Council passed Local Law 22, which requires DSNY to conduct a pilot program for city agency organics collection. The pilot involves building staff and agency tenant training, operational audits and participation tracking for two years. Twelve buildings in Manhattan are participating, including sties as diverse as an NYPD horse stable, the Central Park Zoo, and City Hall.

2. Will funding increase in FY 2020 and do you anticipate funding changes in FY 2021?

In April as part of OneNYC 2050, Mayor de Blasio announced City's intention of creating a citywide mandatory organics program. DSNY looks forward to working with City Council to refine the details of this plan and develop legislation to implement this program.

Currently, residential buildings in every Manhattan community board can enroll in residential organics collection service. DSNY runs 21 organics trucks each week - 7 per day on M/W/F Manhattan residential organics customers. Additionally, the organics school truck services the borough Monday through Friday.

There are currently 270 Outdoor JTPs assigned to DSNY; DSNY feels the program is a success and points to the increase in Scorecard ratings as an indicator (FY19 Manhattan Final 95.8 vs. FY18 Manhattan Final 94.1)

2. What is the current funding and targeted head-count and will these be increased?

Target headcount is 300

3. Of the previous participants in the program, how many have been hired by DSNY on a part-time or full-time basis?

As of 9/9/19, the DSNY has hired a total of 20 participants after completing the program.

The purpose of the Job Training Program (JTP) is to empower JTP participants by placing them in a stimulating work environment that will enhance their employability by providing them with counseling, training and outreach services. To encourage their continual growth, we provide the necessary tools for participants to become successful in securing and maintaining unsubsidized employment. To achieve this goal, JTP Participants work under well-structured, well-supervised, and well-defined assignments.

The JTP does not guarantee employment opportunities or entry into positions within the agency. Within the duration of this 6-month program, it is the responsibility of each Participant to seek unsubsidized employment on their own. However, our Program Administrators actively help participants in their efforts by providing assistance, counseling and encouragement.

### **AGENDA ITEM 12 : Pedestrian Safety**

### **AGENCY RESPONSE:**

DSNY is currently ordering all new collection trucks with sideguards installed by the manufacturer. We are also working with DCAS to identify available funding for sideguard retrofits of existing trucks. Currently there are 159 total vehicles (surpassing the goal of 120) assigned to Manhattan with Vision Zero sideguards installed. We are on track to meet the City's target of installing sideguards on all applicable heavy-duty units by 2024.

In addition to the litter baskets being serviced by tri-weekly refuse collection, all Manhattan districts receive dedicated basket service two to three times daily.

2. What funding would be needed for additional litter basket service for both weekdays and weekends? How many baskets are currently on Manhattan streets?

All community boards now have dedicated basket trucks. Through the \$8.6M FY20 Supplemental Basket Plan, a total of 32 full shift and 12 OT basket trucks weekly provide basket services in Manhattan. (Effective 8/12/19)

There are 9,073 litter baskets in Manhattan.

3. Can you give us a list of the locations of baskets in each Manhattan district? Can you brief us on the types of baskets currently being used by the DSNY (i.e high-end, Big Belly, wire, other) and where they are located?

There are currently 4,378 wire litter baskets in Manhattan. Current price for a HEB is \$695. Total cost to purchase would be \$3,042,710 not including the cost of placing the baskets, \$227,656. Total cost \$3.3M

### **AGENCY RESPONSE:**

(CB 1) What is the status of the RFEI for residential waste storage within the public right-of-way?

The agency received 18 submissions and has completed an initial review process with colleagues at DOT. We have identified two potential pilots and are seeking funding to move forward with implementation.

(CBs 4, 9) Is DSNY allocating additional funds for neighborhoods that are experiencing significant increases in residential population through redevelopment and infill?

The agency regularly monitors for changes in tonnage and makes any necessary adjustments as warranted.

(CB 4) Will the number of packer trucks that service street baskets increase in CD 4?

M-4 will receive OT litter basket service Mon thru Sat as part of the FY20 Supplemental Basket Plan; this went into effect on 8/12/19.
