Dear Ms. Stetzer:

I am writing to inform you that we have received an application for a bus stop from General Bus, Inc. The proposed location is 47 Chrystie Street between Hester and Canal Streets. We are asking for comments from the Community Board on this proposed inter-city bus stop within 45 days of the date of this letter (April 29<sup>th</sup>). Below are the details:

- The stop would be at 47 Chrystie Street between Hester and Canal Streets on the west side of the street, just before the operator's storefront.
- The bus operator is General Bus, Inc.
- The proposed location is currently regulated with truck loading from 8 am - 7 pm, Monday through Saturday
- There will be between 5 drop-offs and 5 pickups daily. The hours of operation will be from 8:30 am to 10:00 pm.
- The stop would be approved for only one bus at a time
- The bus will travel from New York City to North Carolina
