## **April 2003 Resolutions**

At its <u>April 2003</u> monthly meeting, Community Board #3 passed the following motions:

### **TITLE: Chinatown YMCA Beacon Program**

To support the Chinatown YMCA Beacon program.

## **TITLE: Co-Sponsor Forum on Patriot Act II**

To co-sponsor the May 21, 2003 forum on the Patriot Act II.

### TITLE: Purchase of 70 East 4th Street by Downtown Art and Alpha Omega Theatrical Dance, Inc.

To support the purchase by Downtown Art Company, Inc. and Alpha Omega Theatrical Dance, Inc. of 70 East 4th Street, providing the organizations demonstrate their ability to attract funding. The concerns as to their fundraising abilities are not directed specifically at these groups, but to all of the groups developing the East 4th Street Cultural District.

### TITLE: Hare Krishna Food Relief Program to Lease a City-Owned Property

To support the Hare Krishna Food Relief program's request for a lease in a cityowned property.

### TITLE: TLC License Renewal for Allen Car Service, Inc., 37B Orchard Street, New York, NY 10002 (B01472)

To approve the application by Allen Car Service, Inc. for renewal of the TLC license (B01472) for a For-Hire Base at 37B Orchard Street, based on the receipt at the April 29 full Board meeting of the following: 1) a letter from the parking lot explaining that 10 spaces have been rented, 2) a copy of a memo to the drivers explaining quality of life issues and the need to obey traffic regulations.

### TITLE: Signage Changes on South Street between Market and Catherine Slips

To ask that the parking regulations on the NW side of South Street between Market and Catherine Slips be changed from "No standing, Loading and Unloading Zone" to unmetered community parking, with allowances for necessary street cleaning.

#### TITLE: Speed Bumps and Signage on Henry Street between Rutgers and Pike

To request that the DOT install speed bumps and a high-visibility school crossing sign in front of P.S. 2 on Henry Street between Rutgers and Pike.

#### TITLE: Public Meeting for Coach Bus and Commuter Van Loading and Unloading Zones

To cosponsor with Community Board #2, Manhattan a May 7th public meeting regarding joint solutions for the coach bus and commuter van loading and unloading zones, and the layover locations on the Community Board #3 Manhattan's waterfront. We also ask if the meeting could be relocated to an accessible location, and that further public meetings be held in accessible locations.
