September 2003 Resolutions

At its September 2003 monthly meeting, Community Board #3 passed the following motions:

TITLE: Task Force for Section 8 Opt-Outs

To request that the Borough Board set up a task force to prepare a plan to prevent Section 8 opt-outs both now, and in the future. As you know, Section 8 is one of our last sources of affordable housing; the owners who are opting out are almost exclusively in Manhattan. We need a borough response to this problem.

TITLE: Eliminating Section 8 Housing Vouchers Choice Program

To support CCM Lopez's resolution to oppose the President Bush's budget proposal to eliminate the Section 8 Housing Vouchers Choice Program and replace it with block grants to the states; furthermore

To encourage federal elected officials to oppose President Bush's plan to eliminate Section 8 Housing funds and/or combine it with CB Block Grand funds.

TITLE: Renaming Ballfield in Columbus Park

To oppose the proposal by the Fraternal Order of Police Court Officer Lodge #35 for renaming the ballfield in Columbus Park to "New York State Courts Memorial Field" due to lack of community support.

TITLE: Temporary Use of Pier 42

To support the request by Con Edison to temporarily use Pier 42 for cable pulling operations in the East River Park for designated periods.

TITLE: Investigate Method Used by Con Edison to Restore Power to Neighborhood

To request that our elected officials investigate the method used by Con Edison to restore power to our neighborhood and...

To explain why our neighborhood was the last area to have power restored and...

To explain why power was restored to the commercial area before the residential area and...

To request that individuals and businesses be reimbursed for losses and...

To publicize the reimbursement process.

TITLE: TLC License Renewal for Tel Aviv Car Service, 139 First Avenue, New York, NY 10003 (B00887)

To approve the application by Tel Aviv Car Service for renewal of the TLC license (B00887) for a For-Hire Base at 139 First Avenue.

TITLE: TLC License Renewal for Lincoln Limo Service, Inc., 141 Division Street, New York, NY 10002 (B00619)

To approve the application by Lincoln Limo Service, Inc. for renewal of the TLC license (B00619) for a For-Hire Base at 141 Division Street.

TITLE: Signage for South and Cherry Streets and Pike, Catherine and Rutgers Slips

To request that DOT install "Yield to Pedestrians" signs at the intersections of South Street with Pike Slip and Catherine Slips, and that they install "No Standing until 6PM" signs on the east side of Rutgers Slip between South and Cherry Streets.

TITLE: Delancey Street Transportation Study

To ask DCP to hold a public hearing in the study area, as they offered, about the Delancey Street Transportation study in early December upon completion of their analysis of the existing conditions.
