Meeting of Community Board #3 held on Tuesday, January 23, 2007 at 6:45 at PS 20, 166 Essex Street.

#### Public Session:

Dr. Albert Favatis, M.D.--St. Vincent Stroke Awareness Center. They are providing alternative and cutting edge services to stroke patients. Patients who are treated within the first three hours can be given medicine or a procedure. When dialing 911, state that you want to be taken to a comprehensive stroke center.

Andres Puerta-- Organizer for the NYC District Council of Carpenters. Speaking regarding the Pomeranc Hotel at 200 Allen St. He is concerned about working conditions, safety, and area standards. This site is using non-unionized laborers which increases risks to workers.

John Leo-- CPLDC. Presenting Chinese New Year event at Columbus Park. Informational presentation and request for support. The event is on February 18 at 7:00 P.M. There will be illumination pyrotechnics (no noise).

Elizabeth Blatz-- South District Librarian. Thanked the Board for support of Public Libraries. The busiest branch in Manhattan is at Chatham Sq.

Richard Duane—Speaking in opposition to the 78 Second Ave Sandwich Shop application for a sidewalk café application. He is opposed to the application due to prior complaints. He thinks other restaurants next to him will want sidewalk cafes also if this is approved.

Royal Smith-- Representative of Nomad, 78 Second Ave. Sandwich, Inc. Believes that the sandwich shop should be granted a sidewalk café license.

Jonathan Zalisky-- Health Plus, has workshops for different health ailments.

Steven Tin--Better Chinatown Society-- Holding two events in Chinatown on February 18 and February 25 for the Lunar New Year. This is the 5<sup>th</sup> year of the parade. Asking for the Board's support this year.

Congressmember Jerrold Nadler, Erin Drinkwater--

The Congressman introduced a bill to bring home the troops in Iraq by 12/07 and to cap funds.

Congressmember Nydia Velazquez, Not Present

Assembly Speaker Sheldon Silver, Jessica Loesser and Ellen Ruchman-

Pier 35 and 36-- There is going to be a community recreational facility on that site, however, the Office of Emergency Management has vehicles parked there and it is not clear where they will move to or when.

There is a concrete barrier on the FDR Dr. that is supposed to be a pedestrian refuge, but cars are jumping it. DOT has put up a visible sign and has forced cars into a very wide turn. The Assemblyman is very concerned about this.

With regard to affordable housing, Gov. Spitzer rejected the amendment to the proposals by the tenant's association which would have limited affordable housing.

State Senator Martin Connor, Eva Ritteteau--

He has been put in his name as Comptroller and was interviewed today. If selected there would be a special election. He feels that he has a good understanding of what the job entails.

Rules changes were proposed, but quashed by the Republican Majority.

# **Human Services & Seniors Committee**

1. Request for support for paper ballots optical scanner to replace our current mechanical lever voting machines

**DISCUSSION:** Estelle Rubin asked what the new voting machines would be. Carolyn described the different types of machines. The committee and City Council are endorsing an optical scanner that has a paper trail. It will also tell you if you missed something in the vote and won't let you vote twice on the same line.

**VOTE:** Resolution urging the New York City Board of Elections to select a precinct-based Paper Ballot/Optical Scan system as the new voting technology for the City of New York, and urging the New York City Council to go on record as supporting the selection of a precinct-based Paper Ballot/Optical Scan system by passing Resolution 131 as soon as possible.

Whereas, observable election procedures that ordinary citizens can witness, understand, and attest have been properly conducted are the basis for public confidence in elections; and

Whereas, direct recording electronic (DRE) voting machines prevent citizens from witnessing and understanding the handling of votes; and

Whereas, New York State law requires the New York City Board of Elections to select new voting technology to replace the mechanical lever machines which we currently use; and

Whereas, New York State law allows the New York City Board of Elections to select either a precinct-based Paper Ballot/Optical Scan system or a Direct Recording Electronic (DRE) voting system; and

Whereas, paper ballots can be marked by voters with disabilities and/or non-English languages by the use of accessible ballot-marking devices; and

Whereas, precinct-based Paper Ballot/Optical Scan systems can provide the advantages of quick election-day results and accessibility without the risks associated with electronic voting;

Therefore, be it resolved, that Community Board 3 urges the New York City Board of Elections to select a precinct-based Paper Ballot/Optical Scan system as the new voting technology for the City of New York;

And be it further resolved, that Community Board 3 urges the New York City Council to go on record as supporting the selection of a precinct-based Paper Ballot/Optical Scan system by passing Resolution 131 as soon as possible.

# **SLA & Economic Development Committee**

1. SLA's new policy to hear some NYC applications in upstate cities

**VOTE:** WHEREAS, the New York State Liquor Authority (hereinafter "SLA"), in an effort to be fair to applicants in all areas of the State of New York, will conduct hearings in Albany and Syracuse, as well as within the City of New York, and

WHEREAS, Community Board #3, Manhattan, acknowledges that the SLA has been making every effort to be responsive to community and community board needs and recommendations and Community Board #3 wishes to state on record its appreciation of the recent changes instituted by the SLA which have greatly benefited communities, and

WHEREAS, Community Board #3 believes that community board and community resident representation at SLA hearings is an important component of community input during the application process, and

WHEREAS, New York City community boards and residents cannot afford the cost of travel and the loss of a full day of work to attend hearings in Albany or Syracuse, and

WHEREAS, applicants have legal representation paid to attend full board hearings and the inability of community board representatives or residents to attend such hearings may result in an unfair disadvantage to applicants, and

WHEREAS, applicants who are applying to be licensed within New York City, who themselves live and work within the City, as well as their legal representatives with offices within the City, may also be disadvantaged by having to travel great distances to attend hearings;

THEREFORE, Community Board #3 urges the SLA to make every effort to conduct hearings for licenses with community opposition within the city in which the license will be located.

**VOTE:** To approve the renewal of a full on-premise license for Bar On A, 170 Avenue A, with the understanding that the owner will alleviate the existing noise complaints of neighboring residents occasioned by bands and music in his establishment, which includes but is not limited to, installing sound baffling and additional soundproofing and by restricting live bands to earlier hours during the week.

**VOTE:** To approve the application for a sidewalk café permit for four (4) tables and eight (8) seats for 78 Second Avenue Sandwich Shop, 78 Second Avenue, because the applicant has signed a change agreement to close said café at 10:00 P.M. every night which will become part of his DCA license.

**VOTE:** To approve the alteration for Brown Bean, 61 Hester Street, expanding into the adjacent store front which the licensee currently uses as an appended grocery store, with the understanding that the method of operation as a coffee shop/café and hours of operation will remain the same.

Sunday through Thursday and 12:00 A.M. Friday and Saturday, 2) it will maintain its method of operation as a full-service Thai restaurant, serving food to within one (1) hour of closing, 3) liquor service will only be at tables, and 4) its French doors will be closed at 10:00 p.m. every night.

18. Ludlow Café, 87 Ludlow St (alt)

**VOTE:** To deny the application for an alteration, for Ludlow Cafe, 87 Ludlow Street, to wit, increasing its size by 30% by converting an existing storeroom into space for patron seating and use, for the following reasons: 1) the original approved use for this location was a restaurant with closing hours of 12:00 A.M. every night 2) in the past year, this location has had a consistent history of violations with various City agencies, including violations for unlicensed cabaret and bar, as well as numerous violations for serving alcohol to minors (see attached letter from Lt. Joseph Del Duca of the 7th Precinct), which have culminated in two (2) nuisance abatement closings within 2006, 3) this establishment is located on Ludlow Street, which is already overcrowded by traffic and people patronizing existing nighttime businesses and which requires special operations and weekend closing of the street by the 7th Precinct because of the incredible congestion and unruliness occasioned by nighttime patrons and, most recently, Community Board #3 has, at the request of the 7th Precinct, voted to ask the Department of Sanitation to eliminate parking on one side of Ludlow Street between Houston and Delancey Streets, due to this overwhelming congestion, 4) given the existing deleterious conditions on Ludlow Street, Community Board #3 cannot now sanction the expansion of an establishment whose operation is contributing to these conditions and communicated this opinion to the justice overhearing the nuisance abatement action in August of 2006 (see attached letter of Community Board #3), 5) it is the understanding of Community Board #3, based upon discussions with the above-referenced Lieutenant from the 7th Precinct that this applicant has already been improperly operating the space it now seeks to incorporate into its existing license as part of its commercial space for at least the past eight (8) months, and 6) this establishment may be within 200 feet of a school, to wit Seward Park High School.

#### **Public Safety & Sanitation Committee**

1. Request for city regulations to require ultra low sulfur fuel for generators used by film production companies in NYC

**VOTE:** Whereas filming production in Community Board 3 has increased due to recent initiatives to bring more filming to the city for economic benefits, and

Whereas Community Board 3 is viewed as a highly desirable area for filming, and much of the increased filming in the city occurs within Community Board 3, and

Whereas film production necessitates generators for film production and for catering trucks, and these generators produce unhealthy and unpleasant smelling diesel fumes, and

Whereas the Community Board office receives complaints from residents that the fumes are unbearable, and

Whereas the Community Board office receives complaints from merchants saying that the fumes drive people away and has negative impact on their businesses, and

Whereas Community Board 3 understands that filming in New York City brings many economic benefits to the City but also believes that the City should require that every effort be made to mitigate negative impacts on the residents who live and work in the filming location, so

Therefore Community Board 3 requests that the city to pass legislation to require that film production companies use ultra low sulfur fuel when filming in NYC.

2. Report from Con Ed Subcommittee on status of proposals for environmental benefits using settlement monies

3. Support for CB 1 proposal requesting EPA to withdraw its December 2006 "test and clean" program and work with community and elected officials to develop a new testing and cleanup plan for WTC residual contamination

**VOTE:** RE: EPA's 2006 Final Test and Clean Program

WHEREAS: On December 6, 2006, the U.S. Environmental Protection Agency (EPA) released its Final Lower Manhattan Indoor Test and Clean Program, and declared this program the final phase of EPA's response to the national terrorist attacks of September 11, 2001, and

WHEREAS: Community Board #3 unanimously passed a March 2006 resolution calling upon EPA to abandon its technically and scientifically flawed November/December 2005 Test and Clean Program, and

WHEREAS: One year later, without any input from World Trade Center community residents or workers, or CB#3, the EPA released a program which provides grossly insufficient financial resources (only \$7 million) to test and clean all potentially affected residences and workplaces, and which is substantially the same as, but in some key areas worse than, its previous inadequate plan, and

WHEREAS: EPA's December 2006 program fails to correct the major shortcomings of its 2002-3 test and clean program, cited by EPA's Inspector General in a highly critical August 2003 report, including: failure to address potential residual contamination in HVAC systems, failure to test and clean whole buildings as a system, failure to address potential residual contamination in workplaces, failure to expand testing and cleanup beyond the arbitrarily imposed Canal Street boundary line, and failure to incorporate appropriate Science-based testing methods, and

WHEREAS: George M. Gray, the Assistant Administrator for the EPA Office of Research and Development states, that "The vast majority of occupied residential and commercial spaces in Lower Manhattan have been repeatedly cleaned, and we believe the potential for exposure related to dust that may remain from the collapse of the World Trade Center buildings is low." However, the substance of that statement is impossible to verify since the onus for virtually all testing and cleaning undertaken over the past five and a half years was placed upon individual residents, employers, or landlords without proper guidance, oversight or verification, without centralized information collection, and with little or no financial support, from the Federal, State or City government. Moreover, his statement ignores that, in the absence of an appropriate emergency response by EPA, the health of tens of thousands of residents and workers left to their own devices to conduct unsafe cleanups was placed at risk and that, without further scientifically sound large-scale testing, there is no basis for an assertion that the risk that remains to the community is "low", now

THEREFORE, BE IT RESOLVED, THAT: CB#3 rejects EPA's December 2006 plan and expresses outrage at the EPA's failed federal response to the September 11th attack on the United States of America which occurred at the World Trade Center in the heart of our neighborhood, and

BE IT FURTHER RESOLVED, THAT: CB#3 calls upon EPA to withdraw its December 2006 "test and clean" program and work with the community and elected officials to develop a scientifically sound testing and cleanup plan for World Trade Center residual contamination.

IN ADDITION: CB#3 requests that such a plan determine the geographical extent and characteristics of WTC residual contamination in Community Board #3, and clean up contamination that endangers public health.

Correction for previous resolution regarding Asthma Free Zone proposal **VOTE:** To amend the Resolution passed by the full board in June 2006.

#### **Full Board Resolution June 2006:**

Community Board No. 3 supports an initial funding allocation to launch the Asthma Free School Zone Program as outlined in the enclosed attachment. This is a three year project for which Asthma Free School Zone, is requesting an allocation of \$50,000.00 from the Con Ed Settlement Fund.

The funds shall be used in year one to focus on PS 34, East Village, and Children's Workshops schools and in the second year to schools in close proximity to the plant. A total of 12 schools and 6 day care facilities will be helped at the end of the three year implementation program.

CB#3 is requesting consent from all signatories of the settlement funds, Con Edison, NYPIRG, NYS Public Service Commission, and Mayor's Office for re-allocation of the settlement funds.

## Proposed Amended (Corrected) Resolution January 10, 2007:

Community Board No. 3 supports an initial funding allocation to launch the Asthma Free School Zone Program as outlined in the proposal reviewed in May-June 2007. This is a three year project for which Asthma Free School Zone, is requesting an allocation of \$50,000.00 from

the Con Ed Settlement Fund for the first year. AFSZ must return for CB#3 approval for the 2nd and 3rd years of funding.

The funds shall be used in year one to focus on educational facilities (e.g. public schools, preschool, day care) for children in close proximity to the Con Ed plant. A total of 12 schools and 6 day care facilities is proposed to be helped at the end of the three year implementation program.

CB#3 is requesting consent from all signatories of the settlement funds, Con Edison, NYPIRG, NYS Public Service Commission, and Mayor's Office for re-allocation of the settlement funds.

#### **Transportation Committee**

Support for the passage of NYC Council Intro 199 ("The Traffic Information and Relief Bill")

VOTE: Resolution Calling for Passage of NYC Council Intro 199 ("The Traffic Information and Relief Bill")

WHEREAS, traffic congestion in New York City steadily worsens, hindering movement of buses, endangering pedestrians, creating more air and noise pollution that compromises people's well-being and threatens their health, as studies show, with increased risk of illnesses like asthma, diabetes, cancer and heart disease, and costing New Yorkers extensive time loss and unnecessary fuel consumption (2003 figures show an average of \$6.78 billion worth of time lost and 198 million gallons of fuel wasted); and

WHEREAS, upzoning, new development and a projected increase of one million more New Yorkers by 2030 will increase travel demand, further clog our streets and exacerbate the City's traffic problems; and

WHEREAS, the City needs a more comprehensive information base and system of analysis to understand and evaluate existing traffic conditions, weight alternative solutions to reduce their impact and establish a more effective balance of transportation modes that can better server the City's needs for efficient movement of people and goods, better performing streets, increased public transit use and an improve quality of life; and

WHEREAS, NYC Council Intro 199 ("The Traffic Information and Relief Bill") calls for provision by the New York City Department of Transportation (DOT) of detailed information on the location and nature of traffic congestion and other transportation-related problems in the City, to properly analyze and address them on both micro and macro levels and to devise solutions, through an open public process, that allow for modal flexibility and innovations such as pricing, design and regulatory changes, as well as for the establishment of performance measures and targets to achieve and assess these objectives;

THEREFORE BE IT RESOLVED that CB3-Manhattan supports the passage of NYC Council Intro 199 ("The Traffic Information and Relief Bill") and looks forward to working with the New York City Council and DOT to implement its provisions.

- 2. Request to remove or modify loading/unloading sign at 301-305 E 5th St
  - **VOTE:** To ask DOT to reduce the length of the "No Standing Except Loading/Unloading" zone in front of 301-305 E 5 St, by relocating the sign at the west end of the zone to a location just east of the tree located inside the zone. This would decrease the length of the zone from about 70 feet to 50 ft, which should be sufficient for deliveries. This would solve a problem with visibility of the sign, which residents who have been ticketed have complained about.
- 3. 55-59 Chrystie St request for signage change on west side of Chrystie St btwn Canal & Hester Sts be changed to "Passenger Loading and Unloading Only"
  - **VOTE:** To support the tenants' request for a change of signage in front of 55-59 Chrystie St on the west side of Chrystie St between Canal St and Hester St from a "No Standing Except Loading/Unloading" zone to "No Parking Anytime." This building is a commercial building with professional tenants including doctors and rehabilitative counseling services, and CB3 feels that "No Parking" regulations will allow the elderly, handicapped and young children to safely exit and enter their vehicular transportation.
- 4. Support to convert an on-street metered vehicle space to bicycle parking by widening the sidewalk in front of Mud Cafe (307 E 9 St)

**VOTE:** To postpone until February 2007.
