July 2008 Full Board Minutes

Meeting of Community Board #3 held on Tuesday, July 22, 2008 at 6:45 at IS 131, 100 Hester Street

#### Public Session:

Vaylateena Jones- a concerned Lower East Side resident and Community Board 3 member spoke regarding pedestrian safety at the intersection of Rutgers and the FDR Drive where one of the waterfall installations is located. She is concerned about the heavy foot traffic of children in the area without any traffic lights or stop signs. She wrote a letter to the DOT and hopes to get a response soon.

Christine Patz-Romero spoke in support of a Parks Department resolution allowing a launching and landing site at the beach under the Brooklyn Bridge and/or a towing program. The boat landing would be used mainly by kayakers.

Rob Buchman-spoke in support of the boat landing at the Brooklyn Bridge Beach.

Tim Gamble- a volunteer coordinator of Red Hook Boatery and volunteer at the Downtown Boathouse spoke in support of the Parks resolution creating a boat landing at the beach under the Brooklyn Bridge.

Rick Muller-Vice President and founding member of the Downtown Boathouse. He is also in support of the launch/landing site.

David Mazzeo- spoke about the noise coming from Heather's Bar . They've approached the owner and said she hasn't responded to complaints. The complaints generally revolve around about people congregating outside the establishment.

David Perrine-lives across the street from Heather's Bar and is also complaining about the noise. He mentions that her license is up for renewal and asks the board to reconsider an approval.

Charles Molloy-lives across the street from Heather's Bar and has complaints about the noise emanating from the establishment.

Scott Fulmer- expressed opposition to the proposed bar at 26 Ludlow Street.

Emily Choi- also spoke in opposition to the proposed bar at 26 Ludlow St. She translated petitions against the bar in Chinese. She noted there is a school, PS 42 directly across the street from 26 Ludlow. She is concerned about the possibility of second hand smoking, decreased parking, lewd behavior and noise pollution. She read a letter from Wilson Soo, the Site Director at Immigration Social Services, Inc. in which he expressed opposition to the bar especially since he runs an after school anti-drug and alcohol abuse program at PS 42.

David Mashburn-spoke in opposition to the proposed bar at 26 Ludlow citing an increased proliferation of bars in the neighborhood and noise emanating from them.

Margaret Niederland- spoke in opposition to the proposed bar at 26 Ludlow St.

Zulma Zayas-spoke in support of the ULURP 080504HAM, also known as the Dona Petra Santiago Apartments. This new construction on the vacant, city-owned lot at 717-719-723 East 9th Street will consist of one eight story building providing 56 rental housing units for the elderly. Eligible tenants must have an income level below 50% of AMI as they will receive project-based Section 8 rental subsidy and contribute 30% of their income towards rent.

Rocky Chin-spoke announcing an August 20th meeting at IS 41 regarding the redesign of Chatham Sq.

# Public Officials:

Mayor Michael Bloomberg, Lolita Jackson & Pauline Yu: Lolita Jackson announced the annual Community Board barbeque at Gracie Mansion. She thanked Sam Krueger with his help in getting artistic content at Pier 26. She also noted his effort in trying to obtain port-a-potties at the pier. Lolita announced that the LES Girls club will be painting the Jersey barrier and that 300 people viewed the recent fireworks show.

Comptroller William Thompson, Rafael Escano:

Public Advocate Betsy Gotbaum, Simeon Banister:

Borough President Scott Stringer, Greg Kirschenbaum:

Announced that the Office of the Borough President is leading a "Rat Walk-Through" of the areas that have significant rodent problems on Thursday July 24th. Go Green LES was kicked off by the formation of subcommittees for which they are looking for volunteers. He also pointed out that in order to keep construction sites safe they need imput from community regarding hazardous conditions. The Office of the Borough President is asking the community for testimonies regarding the re-zoning plan at the City Planning Commission hearing on Wednesday, August 13th.

Congressmember Carolyn Maloney, Victor Montesinos:

Congressmember Jerrold Nadler, Erin Drinkwater:

Congressmember Nydia Velazquez, Iris Quinones: Maritza Rosario:

The Congresswoman recently announced new legislation (H.R. 6033) to expand home healthcare services by providing younger public housing residents with the training they need to care for their neighbors. She presented El Puente founder Luis Garden Acosta with \$214,000 in federal funds to support a new health education initiative. She recently sent a letter to Chairman Tino Hernandez regarding the severe lack of affordable housing in the district. The Congresswoman is also offering free information and services for those interested in opening a small business. It was also mentioned that she as always, opposes the war in Iraq.

#### Assembly Speaker Sheldon Silver, Zach Bommer:

Assemblyman Silver has had several meetings with the Grand Street Guild Tenants Association and building ownership to ensure that the tenants have a clear understanding of the owners' application for a financial restructuring that will include capital improvements. The tenants have expressed serious concerns about displacement and rent increases. Residents also listed a number of complaints with the management including rat infestation, dirty common areas and leaky plumbing.

Assemblyman Silver attended a public meeting with residents of Chatham Green and Chatham Towers to discuss the issues surrounding the closing of Park Row. NYPD was also in attendance. Silver expressed his disappointment with the City's response to residents demands.

Mobil district offices will be set up next Tues at Clinton and Grand and on Aug 5th at Madison and Jefferson Streets.

Assemblymember Deborah J. Glick, Matt Borden:

The Assemblywoman is trying to stop landlord's practice of phony demolitions. She and other elected officials wrote a letter to the Commissioner of the DHCR expressing their concern with DHCR's proposed regulations of demolitions.

She has also written a letter to the DEP in regards to the recent practice of "fracing" in the Marcellus Shale in upstate NY. This new method of drilling produces significant amounts of wastewater which may be polluting the Catskills/Delaware Watershed, NYC's supply for drinking water.

The Assemblywoman has continued concern over school overcrowding.

Assemblymember Brian Kavanagh, Patrick van Keerbergen: Paula Castro

Eighteen of the bills the Assemblyman supported passed the Assembly. He will vote to approve a future bill that would grant 7% of all tickets sold in the new Yankee Stadium to be designated to low-income fans. He recently introduced a bill to prohibit the use of styrofoam by food service providers including state agencies and contractors, restaurants and retail food vendors. The bill, introduced in partnership with Senator Liz Krueger, would require alternate products that are compostable or recyclable, unless no affordable alternative exists.

#### State Senator Martin Connor:

The Senator mentioned a Bill currently in Senate requiring all new buildings in the State of NY to be built, at least partially, green. It would also grant tax credits for private contractors building green. The Senate Minority Leader appointed him Co-Chair to the NYS Senate Democratic School Governance Taskforce. The Taskforce has had two meetings already, and the third will be on Aug 26th 5-8pm at University Settlement. They will be looking for feedback from parents and teachers regarding the effects of mayoral control of the schools.

Senator Connor mentioned that a new commissioner on the State SLA committee is a native of New York City.

The Senator sponsored a bill that passed both Houses changing the distance of the SLA's 200 foot rule from the center of the doorway of a building to the property line.

State Senator Thomas K. Duane, Romeo Ymalay: The Senator is hosting a financial literacy forum to educate people on how to avoid investment scams.

Councilmember Alan Gerson, Tammy To: The Councilman announced the 3rd Annual Senior Sail which will

take place on Thursday, August 14th.

Councilmember Rosie Mendez, Jessica Nepomiachi:

The Community Board thanked the Councilwoman for granting them a \$5,000 technology grant. Her discretionary expense funding supports nearly 100 non-profits serving District 2 and provides capital funding for schools, housing, service and cultural organizations. This funding will provide a new playground at PS 188, security cameras in two NYCHA buildings and renovations to the Henry Street Settlement's Senior Center.

She joined her City Council colleagues in passing the Fiscal 2009 NYC Budget. She regrets that this budget has significant cuts to programs supporting our low-income and senior neighbors as well as schools. The City Council tried to restore as much funds as possible to the DOE and NYCHA.

#### CB2 & CB3 Astor Place Joint Task Force

Discussion of Conceptual Design for Astor Place and vicinity

**VOTE:** WHEREAS, a conceptual design for Astor Place and Cooper Square was presented to the CB2 & CB3 Astor Place Joint Task Force at meetings in May and June 2008. The June presentation included the following changes that were made in regard to community concerns expressed at the May meeting:

- 1. In response to concerns about nighttime gathering and noise in the newly created southernmost "Village Plaza" (across Fourth Ave from Cooper Park), permanent benches have been removed and the amount of planted area has been greatly increased.
- 2. In response to concerns about noise at the expanded "Alamo Plaza" (which contains the cube sculpture and which will incorporate the closed portion of Astor Place between Lafayette St and Fourth Ave), the number of benches has been reduced and the amount of planted area increased.
- 3. In response to concerns about safety hazards and noise, paving choices will discourage skateboarding, particularly in the "Alamo Plaza."
- 4. In response to concerns about pedestrian safety, DOT agreed to add pedestrian refuge islands at the intersections along Third Ave. It is understood that infrastructure under Third Ave makes the construction of continuous medians prohibitively expensive; and

WHEREAS, DOT has agreed to investigate fencing and gating the "Village Plaza," which will be in DOT jurisdiction but will be maintained by Parks, so that it can be locked at night. It is understood that this will not delay the project; now

THEREFORE, BE IT RESOLVED, that CB3-Manhattan supports the conceptual design for the reconstruction of Astor Place & Cooper Square with the understanding that DOT will come back to the community boards again for both preliminary and final designs.

- 3. Summer Streets: Park Ave closed from 7am to 1pm Aug 9, 16, 23 from Brooklyn Bridge north to 14th St in Community Board 3

**VOTE:** WHEREAS, the Dept. of Transportation will close Park Ave/4th Ave/Lafayette St from the Brooklyn Bridge to 72nd St, which includes Fourth Avenue in CB3, from 7am to 1pm on 3 Saturdays in August; and

WHEREAS, CB3 supports the overall experiment of "Summer Streets" as a way to promote healthy outdoor activity and encourage greater use of bicycles; and

WHEREAS, Community Board members and local elected officials were not involved in the planning of the closing and were not informed until the days, times and streets were fixed; and

WHEREAS, CB3 would have preferred public discussion as to whether the community felt that Saturday morning was the best time for this closure, as it is perceived that this is a time for when businesses are open for working people to run errands in preparations for family time/personal time on Sundays; and

WHEREAS, closure from 7am to 1pm intuitively seems early for people to come out and play in the streets and would have benefited from public discussion; and

WHEREAS, the street closure borders Union Square Park, which is a very heavily used business area, especially on Saturday morning when the Farmers market is in use, and the heavily used crosstown street is often blocked and backed up; now

THEREFORE, BE IT RESOLVED, that DOT should involve the community earlier in planning, especially for future versions of a "Summer Streets" type of event, and CB3 also asks that DOT arrange for heavy traffic enforcement at the 14th St location.

#### VOTE 1: Resolution supporting \$82,488 of Con Edison Settlement Funds for Asthma Free School Zone

WHEREAS, the Con Ed Settlement Fund monies are intended to alleviate the impact of the Con Ed plant; and

WHEREAS, Community Board 3 contains the 14th Street Con Edison power plant, the Manhattan sides of the Williamsburg, Manhattan, and Brooklyn Bridges, and the FDR Drive. Despite these significant pollution sources, air quality in this neighborhood has not been characterized in any systematic manner; and

WHEREAS, the Asthma Free School Zone Project (AFSZ) has submitted a proposal to CB3 titled "Assessment of Air Quality in Various Locations within Community Board 3 and Identification of 'Hot Spots' That May Adversely Affect Health of CB3 Residents' (see attached). This project would entail development of a network of samplers to elucidate the spatial distribution of "hot spots", times when pollutant concentration levels are highest, and chemical composition of those pollutants. The findings from this study will guide CB3 to develop site-specific strategies for pollution reduction; and

WHEREAS, AFSZ has agreed to consult with the Con Ed Environmental Settlement Fund Subcommittee regarding final site locations. AFSZ has also agreed that air pollution equipment purchased with Con Ed Settlement funds can be used by other organizations recommended by CB3 at no cost following the study's completion; now

THEREFORE, BE IT RESOLVED, that CB3-Manhattan requests \$82,488 funding for "Assessment of Air Quality in Various Locations within Community Board 3 and Identification of 'Hot Spots' That May Adversely Affect Health of CB3 Residents." This would be funding additional to the \$50,000 requested in our May 2008 resolution for a separate AFSZ project to provide asthma education and mitigation strategies to schools within CB3 and other projects to address respiratory health problems in the area of the Con Edison plant. (see attached proposal)

**VOTE 2:** Community Board 3-Manhattan authorizes our legal representative to renegotiate the terms of the Con Ed settlement fund in order to reallocate expenditures to pollution reduction programs and projects. We authorize him to suspend fuel switching expenditures in the remaining years of the settlement without need for further CB3 consultation. We authorize him to negotiate the extension of the original 10 year time limits for expenditures from the fuel switching and steam accounts and to keep CB3 informed about these negotiations as we would need to approve any change in terms.

**VOTE:** To approve statement of needs as amended

# **Renewal with Complaint History**

2. Double Down NYC, 14 Ave A (op)

**VOTE:** To approve the renewal of the full on-premise liquor license for Double Down, 14 Avenue A, understanding that the applicant will continue to operate this establishment consistent with its previously signed notarized stipulations which have become conditions of its license.

3. Chow Main Corp (China One), 204 E 4th St (op)

**VOTE:** To deny the renewal of the full on-premise liquor license for Chow Main, 204 East 4th Street, because the current method of operation of a nightclub is inconsistent from the method of operation of a full-service Chinese restaurant which was proposed in its original application to Community Board #3. Complaints from residents regarding noise from patrons and garbage piled on the sidewalk, and police violations for overcrowding and the sale of alcohol to minors, evince an establishment that has become a nuisance to the neighborhood and that contributes to pedestrian traffic which has already negatively impacted this neighborhood.

#### **Cabaret Application**

4. Orchard Foods, 152 Orchard St

**VOTE:** To deny the approval of a cabaret license to Orchard Foods, 152 Orchard Street, because 1) this establishment has not demonstrated that it can adequately address complaints of noise, in that it is still receiving complaints despite its assertion that it has installed soundproofing, 2) this establishment has been allowing unlicensed dancing since it began operating in 2006 and the approval of a cabaret license would merely serve to condone this already illegal conduct, and 3) the addition of a cabaret license to 152 Orchard Street, between Stanton Street and Rivington Street, would exacerbate the current conditions on this narrow one-way street which is already overwhelmed with nightlife establishments and which is so heavily trafficked by people and vehicles that Community Board #3 and the 7th Precinct have had to ask the Department of Transportation to eliminate weekend nighttime parking on one side of this street, from Houston Street to Delancey Street.

# Sidewalk Café Application

5. Pan Asian Bistro, 172 Orchard Street (unenclosed)

**VOTE:** To approve the application for a sidewalk café permit for eight (8) tables and (16) seats for Pan Asian Bistro, 172 Orchard Street, because the applicant has signed a change agreement which will become part of its DCA license that 1) it will close no later than 10:00 P.M. every night, 2) it will have an awning extended over its café during its hours of operation to baffle any noise which might be heard by the residential tenants, and 3) it will not apply to serve alcohol at its sidewalk café. Community Board #3 strongly believes that the granting of an extension of this liquor license onto Orchard Street, a narrow one-way street which is already overwhelmed with nightlife establishments and heavily trafficked by people and vehicles, would only further exacerbate a condition that is already overextending local police resources as they seek to control traffic and noise in this area.

6. EU, 235 E 4th St (unenclosed)

**VOTE:** To approve the application for a sidewalk café permit for fourteen (14) tables and twenty-eight (28) seats for EU, 235 East 4th Street, because the applicant has signed a change agreement which will become part of its DCA license that 1) its hours of operation will be from 11:00 A.M. to 10:00 P.M. Sundays through Thursdays and 11:00 A.M. to 11:00 P.M. Fridays and Saturdays, which include any time needed to set up or break down the café.

- 7. El Sayed, 293 E 10th St (unenclosed) withdrawn
- 8. Moonstruck, 88 2nd Ave (enclosed) no vote necessary
- 9. Brooklyn Bar, 158 Ave C (unenclosed)

WOTE: WHEREAS, Brooklyn Bar, 158 Avenue C, located between 9th Street and 10th Street, is seeking to extends its method of operation to include the operation of a sidewalk café, consisting of twelve (12) tables with twenty-four (24) seats; and

WHEREAS, Avenue C is a narrow street with two (2) lanes of traffic running from Houston Street to 12th Street; and

WHEREAS, there are twelve (12) licensed establishments on Avenue C between 8th and 10th Streets, five (5) of which are full on-premise liquor licenses on the same block between 9th and 10th Streets as the herein applicant; and

WHEREAS, the cumulative impact of these six (6) establishments along one small block is significant noise and sidewalk congestion at nighttime; and

WHEREAS, said applicant is located in a corner storefront, in and adjacent to residential buildings on both Avenue C and 10th Street; and

THEREFORE, BE IT RESOLVED that Community Board #3 moves to deny the sidewalk café application for Brooklyn Bar, 158 Avenue C, because of the existing pedestrian and vehicular traffic conditions on this block as a result of the existing licensed establishments and because the extension of this business onto the sidewalk would not be of any public benefit.

10. Brookyln Bar, 158 Ave C (alt/sidewalk café) no vote necessary

11. Bernie's, 121 Ludlow St (rw)

**VOTE:** WHEREAS, Bernie's is applying for a restaurant wine license for 121 Ludlow Street and did not appear before Community Board #3 for review of its application or provide any application materials to review; and

WHEREAS, Ludlow Street is an extremely old, narrow street, historically comprised of low-rise tenements and small-scale manufacturing and retail; and

WHEREAS, Ludlow Street is presently overwhelmed by nighttime licensed establishments of all types, as well as incredible vehicular and pedestrian traffic congestion attendant to the volume of these businesses; and

WHEREAS, Ludlow Street may be the single worst area in the 7th precinct in terms of degraded quality of life the result of so many licensed establishments within close proximity to each other, overwhelming pedestrian and vehicular traffic, patrons congregating in the street itself, late night horn honking and overwhelming noise emanating from businesses and from patrons as they move between businesses; and

WHEREAS, these persistent detrimental conditions have resulted in the 7th Precinct and Community Board #3 petitioning the department of Transportation to eliminate weekend nighttimes parking on one side of Ludlow Street, between Houston and Delancey Streets, to alleviate the existing pedestrian and traffic congestion and to minimize noise; and

WHEREAS, there are presently ten (10) licensed establishments within five hundred (500) feet of 121 Ludlow Street, at least half of which are full on-premise liquor licenses;

THEREFORE, BE IT RESOLVED that Community Board #3 moves to deny the full on-premise liquor license for Bernie's, 121 Ludlow Street.

15. Three Monkeys, 99 Rivington Street (rw)

**VOTE:** WHEREAS, Three Monkeys, is seeking to obtain a restaurant wine license to serve beer and wine at a Israeli restaurant, at 99 Rivington Sreet, located at the intersection of Rivington Street and Ludlow Street; and

WHEREAS, Community Board #3 has long held that the increase in nighttime venues in this area has resulted in persistent and numerous complaints regarding increased noise as well as increased pedestrian and vehicular traffic and said complaints have evolved over time from complaints that were once only about specific rowdy businesses to complaints that are now about noise and congestion resulting from the sheer volume of eating and drinking establishments; and

WHEREAS, said conditions continue to be prevalent in and around Ludlow Street between Houston Street and Delancey Street which currently has twenty-one (21) eating and drinking establishments and Rivington Street between Norfolk Street and Orchard Street which currently has eleven (11) eating and drinking licenses; and

WHEREAS, the Seventh Precinct and Community Board #3 has asked the New York City Department of Transportation to permanently change signage on the west side of Ludlow Street between Houston Street and Delancey Street to "NO STANDING FROM 11:00 P.M. TO 6:00 A.M. FRIDAYS AND SATURDAYS" because the street and sidewalks have been overwhelmed by nighttime businesses and their attendant vehicular and pedestrian traffic and noise creating unsafe conditions for pedestrians and prevent police and other emergency vehicles from traveling down this street (Community Board #3 motion of November 2006 attached hereto); and

WHEREAS, said request has resulted in the New York City Department of Transportation permanently changing signage and eliminating residential parking on the west side of Ludlow Street

between Houston Street and Delancey Street in response to the overwhelming street and sidewalk congestion and the unsafe conditions; and

THEREFORE, BE IT RESOLVED that Community Board #3 denies the application for a restaurant wine license for Three Monkeys, 99 Rivington Street.

16. Hop Devil Grill, 125-129 St Marks Pl (alt/adding outside tables)

**VOTE:** WHEREAS, Beer Bros, Inc, d/b/a Hop Devil Grill, is seeking an alteration of its existing full onpremise liquor license for 125-129 St. Mark's Place, to wit extending its liquor license to the sidewalk to permit the service of alcohol at tables within its stoop line; and

WHEREAS, there has been demonstrated consistent opposition to the addition of any liquor licenses on this block of St. Mark's Place between First Avenue and Avenue A which currently has eighteen (18) licensed establishments, the majority of which are full on-premises licenses and located adjacent to or across the street from the applicant; and

WHEREAS, St. Mark's Place is presently overwhelmed with rowdy nighttime licensed establishments, including that of the applicant, has significant pedestrian and vehicular traffic and noise attendant to the operation of those establishments and has been the target of concentrated police activity to alleviate those conditions; and

WHEREAS, the applicant has received at least five (5) violations for selling alcohol to minors between 2005 and 2008 and Community Board #3 does not believe that the applicant has adequately addressed those violations, in that at least two (2) of them were received subsequent to the intervention of the New York Police Department and the New York State Supreme Court with a stipulation governing the establishment's continued operation and engaging in prophylactic measures to prevent future sales to minors; and

WHEREAS, there have been complaints from residents regarding noise from this and adjacent establishments; and

WHEREAS, give the violation history of the applicant regarding the sale of alcohol within is premise, extending its full on-premise liquor license to the public sidewalk would be of no public benefit and would only serve to exacerbate existing congestion and noise attendant to this and adjacent establishments;

THEREFORE, BE IT RESOLVED that Community Board #3 denies the alteration application for Beer Bros, Inc, d/b/a Hop Devil Grill, to wit extending its full on-premise liquor license for the purpose of selling alcohol on the sidewalk.
