September 2013 Full Board Minutes

Meeting of Community Board #3 held on Tuesday, September 24, 2013 at 6:30pm at PS 20, 166 Essex Street.

Public Session:

- Ann Mitcheltree: Spoke regarding the importance of union labor to city services.
- Dale Goodson: Speaking on behalf of Ave. A Neighborhood Assoc., clarified that his group is not a "oneissue" group but are misunderstood because they are only heard speaking against saturation of liquor licenses.
- Paul Seres: Spoke on behalf of the DL asking to meet with community group.
- Edwin Morris: Spoke to say that the DL is a good looking place with a lot of security and discipline. The management has been receptive to a lot of community pressure.
- Jonas Pelli: Speaking as Assistant Manager of the DL, spoke to say that they have accommodated community (including the hotel across the street) and invited community groups against the DL to speak with them.
- Morris Faitelewicz: Speaking as CB3 member and board member of a housing development, spoke against blocking curb cuts – he complained that drivers ignore them and police do not enforce the law.
- Vaylateena Jones: Speaking for LES Power Partnership, spoke regarding First Aid and CPR training (Friday 10/11 from 6:30-9:30). Also spoke to remind community that deadline for WTC Victims Compensation Fund is October 3.
- Ty Trippett: Spoke to thank SLA committee for denying renewal of the permit for the DL.
- Mae Lee: Spoke regarding immigration reform event (sponsored by New Yorkers for Real Immigration Reform) at Cadman Plaza, including march across Brooklyn Bridge.

Board Member Comment:

David McWaters: Resigned from community board for personal reasons. He stated the greatest honor he had in his life was the four years he served as chair of CB3. He thanked Margarita Lopez for her call to service, Susan Stetzer for her work ethic and organizational skills, Andrew Berman for his work on the rezoning effort, Harvey Epstein for committing to doing the right thing, for the leadership and selflessness of Dominic Berg, Ann Johnson for her support, Richard Ropiak as an example of a leadership, Linda Jones for her work on SPURA, our elected officials for their strong leadership, Lisa Kaplan for setting the bar high, Gigi Li for being a great young leader. He forgave all those that have wronged him, and he hoped others had forgiven him.

Assembly Speaker Sheldon Silver, Amy Schroeder: Speaker spent the summer advocating for more funds for Knickerbocker recovery from Sandy.

Assemblymember Deborah J. Glick, Sarah Malloy-Good: Not Present

Assemblymember Brian Kavanagh, Marcela Medina: Assemblymember had a bookbag handout in the neighborhood. On October 5, there will be a Sandy commemorative event.

State Senator Daniel L. Squadron, Mauricio Pazmino: Not Present

State Senator Brad M. Hoylman: Congratulated David McWaters on his service. There will be a forum on the economics of hydrofracking, at 10/3 at the SVA Theater (23rd and 8th Ave.). There was a rash of crime against

LGBT community members in Manhattan. In response, we held a forum on the current legislation, which was passed ten years ago. The state should re-examine that law and he made recommendations to the state which is available on the website.

Councilmember Margaret Chin, Patricia Olan: SPURA developer was selected and the new plan includes a new Essex St. Market (with move costs for vendors covered by the city), a school by the Educational Alliance, a community center run by Grand St. Settlement and 250,000 sq. feet of office space. This will also created permanent jobs and opportunities for residents to get involved in the construction trades. Also, the City Council approved the landmarking of the Seward Park library. At the transportation committee, the Councilmember advocated against casino buses because they are shuttle buses and not intercity buses (which create intercity partnerships).

Councilmember Rosie Mendez, Rosemarie Diaz: Recently was able to pass a tax benefit for Habitat for Humanity cooperative. Successfully overrode veto. Renamed East 13th Street after Cornell Edwards, a former chair of the Community Board housing committee. There are new board members of NYCHA, which includes 3 resident members and a member of EDC. Construction of Star Academy will begin and go no later than 10:00PM each day.

Transportation & Public Safety and Environment Committee

1. Request for traffic light at PS 184,327 Cherry St and School of Int'l Studies at 220 Henry St

VOTE: WHEREAS, Traffic conditions are unsafe for pedestrians along the stretch of Clinton St between Cherry St and Henry St. Vehicles routinely ignore the stop sign at the intersection of Clinton St and Cherry St, which is adjacent to the Cherry Street Playground and near PS 184. There is only a school crossing sign at the intersection of Clinton St and Cherry St, which is adjacent to the Henry Street School for International Studies and an ambulance entrance to the Gouverneur Diagnostic Center; now

THEREFORE BE IT RESOVED, that CB3 asks DOT to look at the intersection of Cherry St and Henry St and of Clinton St and Cherry St to determine whether installation of a traffic light is warranted.

- 2. Request for speed bumps at 100 and 150 Cherry Street
 - no vote necessary
- 3. Request to co-name E 2nd Street between Aves A B as Mary Spink Way

VOTE: Resolution Supporting Co-Naming the Block of E 2nd St between Aves A and B as Mary Spink Way

WHEREAS, Mary Spink lived on the block of E 2nd between Aves A and B; and

WHEREAS, [WE NEED COMMEMORATIVE LANGUAGE EXPLAINING WHY MARY SPINK WAS IMPORTANT TO THE COMMUNITY]; and

WHEREAS, CB3 was presented with a petition in support of co-naming the block of E 2nd St between Aves A and B as Mary Spink Way. There were 120 signatures representing 220 of the residential units on the block, an indication of substantial community support. The group advocating for co-naming will continue to collect signatures to surpass the 75% threshold in the CB3 street co-naming guidelines since May 2006; now

THEREFORE BE IT RESOLVED, that CB3-Manhattan formally requests the NY City Council and the Mayor to enact legislation that E 2nd St between Aves A and B in Manhattan's Lower East Side be conamed "Mary Spink Way."

VOTE: WHEREAS, DOT has proposed installing on-street bicycle parking in the parking lane at the following locations. These bike corrals would provide nine-ten bike parking spaces where they replace the space currently used for one parked car. There is a great need for more bike parking in these areas, with

bikes cluttering the narrow sidewalk, often attached to a tree, to other street furniture, etc. Each of these bike corrals would have a local business as a maintenance partner, responsible for maintaining plantings, shoveling snow, etc.:

- A bike corral in front of 85 Orchard St at Broome St with space for 12 bikes to park. Dudley's would maintain this bike corral.
- A bike corral in front of 144 Orchard St & Rivington St with space for 10 bikes to park.
 Goodfella's would maintain this bike corral, which would be installed around the corner from the existing bike corral at 90 Rivington Street maintained by Teanyssimo and Misrahi Realty.
- A bike corral in front of 300 E 9th St at 2nd Ave with space for 20 bikes to park. Veselka would maintain this bike corral, which would be near the bike corral maintained by Mud Cafe
- A bike corral in front of 144 2nd Ave at E 9th St with space for 18 bikes to park. This bike corral would be aligned with the "floating lane" of vehicle parking adjacent to the bike lane and would remove one vehicle parking space. Village Farm would maintain this bike corral, which would be around the corner from the bike corral that would be maintained by Veselka; now

THEREFORE, be it resolved, that CB3-Manhattan supports the installation of these bike corrals of onstreet bike parking.

Bus Stop Permit Applications

7. NYC Style Limo Inc, 95 Canal Street

VOTE: WHEREAS, NYC Style Limo Inc has applied for a designated bus stop for curb-side loading/unloading operations located at 103 Canal St. The buses will provide service between New York and Georgia and Ohio with up to 3 arrivals/departures daily between the hours of 9:30 am and 9:30 pm; and

WHEREAS, the applicant has entered into an agreement with CB3 to adhere to the following stipulations:

- Tickets will be sold only online, or at a designated ticket agency not on the street.
- Tickets will be sold only for specific boarding times and will not be oversold.
- Tickets will be sold in assigned boarding order system so that customers will not need to arrive early to jockey for positions.
- Sidewalk lines will be single file, and only for the next assigned bus.
- There will be a staff person on duty for every arrival and departure to guide loading / unloading, to have direct contact to dispatch to inform passengers of delays, and to engage in crowd and noise control.
- Trash bags will be used to collect litter and will be kept in storefront, or will leave with the bus.
- Staff will routinely clean up the sidewalk by bus stop.
- Buses will keep to schedules, which will be published online or printed, as much as possible.
- The number of buses at this stop will not exceed the stated number of buses per hour/per day.
- All buses purchased in the future will be equipped with diesel particulate filters and use ultra-low sulfur fuels, and will also be equipped with exhaust gas recirculation emission control technology.
- A storefront will be provided for the use of customers, so they may wait to board their bus and use the restroom facilities; now

THEREFORE, BE IT RESOLVED, that CB3-Manhattan recommends that DOT issue a permit for NYC Style Limo Inc to operate their bus service at a designated curbside bus stop at 103 Canal St, provided that the preceding list of stipulations agreed between the applicant and CB3 will be attached to the DOT permit.

8. Blue Sky Bus Tours Inc, 51 Chrystie Street

VOTE: WHEREAS, Blue Sky Bus Tours Inc. has applied for a designated bus stop for curb-side loading/unloading operations located at 51 Chrystie Street. The buses will be providing service between New York and cities in North Carolina and South Carolina with up to 2 arrivals/departures daily between the hours of 7:00 am and 10:00 pm; and

WHEREAS, CB3 has serious concerns about this location because it might eliminate a truck loading zone from 8am to 7pm, Mon-Sat, on a block that has existing businesses that require loading and unloading. Three of these businesses appeared at the CB3 meeting in April 2013 to present their concerns – Sun Da Apparel (a garment factory on the 2nd floor of 47-53 Chrystie St), Hollywood Nail Supplies (a business at 51 Chrystie St), and An Qing Corp (a restaurant supply business at 53 Chrystie

St). There is already another permitted bus stop for Lucky Star and for General Bus located on the same block at 55 Chrystie St; and

WHEREAS, the applicant has entered into an agreement with CB3 to adhere to the following stipulations:

- Tickets will be sold only online, or at a designated ticket agency not on the street.
- Tickets will be sold only for specific boarding times and will not be oversold.
- Tickets will be sold in assigned boarding order system so that customers will not need to arrive early to jockey for positions.
- Sidewalk lines will be single file, and only for the next assigned bus.
- There will be a staff person on duty for every arrival and departure to guide loading / unloading, to have direct contact to dispatch to inform passengers of delays, and to engage in crowd and noise control.
- Trash bags will be used to collect litter and will be kept in storefront, or will leave with the
- Staff will routinely clean up the sidewalk by bus stop.
- Buses will keep to schedules, which will be published online or printed, as much as possible.
- The number of buses at this stop will not exceed the stated number of buses per hour/per day.
- All buses purchased in the future will be equipped with diesel particulate filters and use ultra-low sulfur fuels, and will also be equipped with exhaust gas recirculation emission control technology.
- A storefront will be provided for the use of customers, so they may wait to board their bus and use the restroom facilities during all times of arrivals/departures.

THEREFORE, BE IT RESOLVED, that CB3-Manhattan requests that DOT resolve the problems with the loading/unloading zone before DOT issues a permit for a designated bus stop at 51 Chrystie Street. If DOT does issue a permit for Blue Sky Bus Tours Inc. to operate at a designated bus stop for curb-side loading/unloading operations located at or near 51 Chrystie Street, the preceding list of stipulations agreed between the applicant and CB3 should be attached to the DOT permit.

9. Asian Express Travel Inc, 30 Pike Street

VOTE: WHEREAS, Asian Express Travel Inc. has applied for a designated bus stop for curb-side loading/unloading operations located at 30 Pike Street, between Madison and Henry St. The buses would be providing service between New York and casinos in Bethlehem, PA, with up to 4 arrivals/departures daily between the hours of 8:30 am and 2:45 am; and

WHEREAS, the applicant operates a casino bus, which the community feels does not provide a public benefit, and in fact negatively impacts the quality of life for local businesses and residents in the area; and

WHEREAS, there was significant community opposition to this application for all of the reasons explained above; now

THEREFORE, BE IT RESOLVED that CB3-Manhattan recommends that DOT should not issue a permit for Asian Express Travel Inc. to operate their bus service at a designated curbside bus stop at 30 Pike Street.

10. A&W Inc, 9 Chatham Square

VOTE: WHEREAS, A&W Inc. has applied for a designated bus stop for curb-side loading/unloading operations located at 9 Chatham Square. The buses would be providing service between New York and casinos in Bethlehem, PA, with up to 8 arrivals/departures daily between the hours of 8:30 am and 7:00 am; and

WHEREAS, the applicant operates a casino bus, which the community feels does not provide a public benefit, and in fact negatively impacts the quality of life for local businesses and residents in the area; and

WHEREAS, CB3 is concerned that the applicant would not agree to provide a storefront for the use of customers, so they may wait to board their bus and use the restroom facilities. This will inevitably cause crowds of passengers jockeying for position on the sidewalk, which will create nuisance and safety issues; and

WHEREAS, Chatham Square is a very congested, complex group of intersections with at least 8 lanes of traffic moving into and through the Square. There is already an existing bus stop for Victoria's Tours at the proposed location operating 11 arrivals/departures daily, and adding an additional 8 arrivals/departures for A&W, Inc. would be burdensome; and

WHEREAS, there was significant community opposition to this application for all of the reasons explained above; now

THEREFORE, BE IT RESOLVED that CB3-Manhattan recommends that DOT should not issue a permit for A&W Inc. to operate their bus service at a designated curbside bus stop at 9 Chatham Square.

11. Yo Bus, 2 Pike Street (expansion of service from 14 daily round trips to 28 daily round trips by adding a second stop at the site)

[NO QUOROM FOR THIS VOTE. RECOMMEDATION ONLY]

VOTE: Whereas, Greyhound/Peter Pan has applied to expand the service provided by their Yo! Bus brand of buses at the designated bus stop for curb-side loading/unloading operations located the small median on the west side of Pike Street between Division Street and East Broadway (the closest street address is 2 Pike Street). Yo! Bus proposes to expand from 14 to 28 arrivals/departures per day, to provide service to Washington, DC in addition to Boston and Philadelphia, and expand hours from 7am-10pm to 7am-12:30am; and

Whereas, Yo! Bus currently has a permit to operate 14 arrivals/departures at this location in a existing bus stop that is over 100'. The current bus stop is already overwhelmed by the 28 pickups and dropoffs between 7am-10pm. With the existing level of service, more than one bus is often at the bus stop, causing spillover into the intersection of Pike St and Division St of buses and waiting passengers; and

Whereas, Chinatown as a whole is presently overburdened with intercity buses and is already home to 28 pickups and drop-offs by Yo! Bus, which is not a locally owned small business, CB3 feels it would be more appropriate for the additional stop to be located in another community underserved by intercity bus service; now

Therefore, be it resolved that CB3-Manhattan recommends that DOT should not expand the permit for Greyhound/Peter Pan to operate their Yo! Bus brand of bus service at the designated curbside bus stop near 2 Pike St. CB3 would, however, approve of the expansion of hours to allow the existing 14 arrivals/departures between 7:00 am to 12:30 am.

ALTERNATE MOTION FOR TRANSPORTATION #11 - Yo Bus, 2 Pike Street

WHEREAS, Greyhound/Peter Pan has applied to modify its permit for its designated bus stop for curb-side loading/unloading operations located on the small median on the west side of Pike Street between Division Street and East Broadway (the closest street address is 2 Pike Street). Yo! Bus proposes to expand to 21 arrivals/departures daily between the hours of 7am and 12:30am and to add service to Albany and Washington, DC: and

WHEREAS, Yo! Bus currently has a permit to operate at this location in a designated bus stop that is over 100' long, providing service to Boston and Philadelphia with up to 14 arrivals/departures daily between the hours of 7am and 10pm; and

WHEREAS, the applicant has entered into an agreement with CB3 to adhere to the following stipulations:

- Tickets will be sold only online, or at a designated ticket agency not on the street.
- Tickets will be sold only for specific boarding times and will not be oversold.
- Tickets will be sold in assigned boarding order system so that customers will not need to arrive early to jockey for positions.
- Sidewalk lines will be single file, and only for the next assigned bus.
- There will be a staff person on duty for every arrival and departure to guide loading / unloading, to have direct contact to dispatch to inform passengers of delays, and to engage in crowd and noise control.
- Trash bags will be used to collect litter and will be kept in storefront, or will leave with the bus.
- Staff will routinely clean up the sidewalk by bus stop.
- Buses will keep to schedules, which will be published online or printed, as much as possible.
- The number of buses at this stop will not exceed the stated number of buses per hour/per day.
- All buses purchased in the future will be equipped with diesel particulate filters and use ultra-low sulfur fuels, and will also be equipped with exhaust gas recirculation emission control technology.
- A storefront will be provided for the use of customers, so they may wait to board their bus and use the restroom facilities; now

THEREFORE, BE IT RESOLVED, that CB3-Manhattan recommends that DOT modify the permit for Greyhound/Peter Pan to operate their Yo! Bus brand of bus service at the existing designated curbside bus stop on the west side of Pike Street between Division Street and East Broadway, provided that the preceding list of

stipulations agreed between the applicant and CB3 will be attached to the DOT permit. The modification would allow expansion of service to 21 arrivals/departures daily between the hours of 7am and 12:30am and to add service to Albany and Washington, DC.

Chung: Concerned that there was an ongoing problem of Yo! Bus.

Ulmet: Also concerned that the new motion does not address the increasing problem.

Crane: Wants DOT to devise a queuing space for buses.

Lisa Kaplan: Asked why we could not pull the motion.

Crane: We only have a forty-five day window to comment (early October).

2. B4 (B4NYC LLC), 235 E 4th St btwn Aves A & B (op)

VOTE: Understanding that this is a sale of assets of a preexisting restaurant with a full on-premise liquor license, Community Board #3 moves to deny the application for a full on-premise liquor license for B4NYC LLC, for the premise located at 235 East 4th Street, between Avenue A and Avenue B, unless the applicant agrees before the SLA to make as conditions of its license the following signed notarized stipulation that

- 1) it will operate as a full-service seasonal American restaurant, with a kitchen open and serving food to within one (1) hour of closing,
- 2) its hours of operation for its interior area will be 8:00 A.M. to 12:00 A.M. all days and its hours of operation for its sidewalk café, comprised of fourteen (14) tables and twenty-eight (28) seats, will be 5:00 P.M. to 11:00 P.M. Mondays through Thursdays, 11:30 A.M. to 11:00 P.M. Fridays and Saturdays and 11:30 A.M. to 10:00 P.M. Sundays,
- 3) it will play ambient background music only, consisting of recorded music, and not have live music, DJs, promoted events, scheduled performances or any event at which a cover fee will be charged,
- 4) it will close any façade doors and windows at 10:00 P.M. every night,
- 5) it will not apply for any alteration in its method of operation without first appearing before Community Board #3,
- 6) it will not have "happy hours,"
- 7) it will not host pub crawls or party buses, and
- 8) it will provide a telephone number for residents to call with complaints and immediately address any resident complaints.
- 3. Wolfnights (Howling Inc), 99 Rivington St @ Ludlow St (wb)

- 5) it will have a closed fixed façade with no open doors or windows,
- 6) it will not apply for any alteration in its method of operation without first appearing before Community Board #3,
- 7) it will not seek an upgrade in class of its liquor license,
- 8) it will not have "happy hours,"
- 9) it will not host pub crawls or party buses,
- 10) it will insure that there are no wait lines outside, and
- 11) it will provide a telephone number for residents to call with complaints and immediately address any resident complaints

Community Board #3 is approving this application for a beer wine license although this is a location within five hundred (500) feet of numerous liquor licenses because 1) this applicant has been operating without

complaint for five (5) years, and 2) it provided numerous signatures from block residents in support of this application and several residents appeared before this community board to speak about the responsiveness and character of the applicant.

6. Papaya King (PKNY II LLC), 3 St Marks PI btwn 2nd & 3rd Aves (b)

VOTE: WHEREAS, PKNY 2 LLC is seeking a beer license to operate a fast food hot dog store, with a proposed business name of Papaya King, for the premise located at 3 St. Mark's Place, between Second Avenue and Third Avenue; and

WHEREAS, this applicant was previously heard as a beer wine application by Community Board #3 in May of 2013 and denied, and

WHEREAS, although this applicant also owns a Papaya King located at 179 East 86th Street which has been open for eighty (80) years, the applicant has only owned this franchise for a few years, the existing Papaya King has always been operated without a liquor license and it exists on a substantially larger street, that being Third Avenue, a major commercial avenue, as opposed to St. Mark's Place which is a one way street that is residentially zoned; and

WHEREAS, this applicant is not proposing to operate a full-service restaurant but, rather, is intending to operate a fast food store serving hotdogs and sides with limited seating and counter service designed for the quick turn-around of patrons and this method of operation is not compatible with the service of beer; and

WHEREAS, the applicant failed to provide substantial community support from area residents in that, although five (5) people appeared in support of this applicant, only one of them lives within this community board district and the applicant furnished Community Board #3 with only thirty (30) petition signatures from area residents in support of its application, although this is a densely residential street where most of the buildings are residences; and

WHEREAS, the applicant has conceded that there are twenty (24) liquor licenses on this one block, composed of eleven (11) full on-premise liquor licenses, ten (10) beer wine licenses and three (3) retail beer wine and liquor licenses; and

WHEREAS, when this application was heard in May of 2013 for a beer wine license, the St. Mark's Block Association and 8 St. Mark's Tenants' Association submitted letters and testimony in opposition to this application, siting the already overwhelming pedestrian and vehicular traffic on the street as a result of all of the existing licensed businesses, as well as the loud music and patrons at this business in the few days it had been open; now

THEREFORE, BE IT RESOLVED that Community Board #3 moves to deny the application for a beer license for PKNY 2 LLC, with a proposed business name of Papaya King, for the premise located at 3 St. Mark's Place, between Second Avenue and Third Avenue.

7. Mikes Burgers & Bar (BAC 115 Corp), 115 St Marks Pl bwtn 1st Ave @ Ave A (upgrade/op)

VOTE: WHEREAS, BAC 115 Corp., doing business as Mike's Burgers & Bar, is seeking a change is class of its liquor license to a full on-premise liquor license, for the premise located at 115 St. Marks Place, between First Avenue and Avenue A; and

WHEREAS, this applicant was denied a beer wine license by Community Board #3 when it applied as an Asian restaurant in April of 2010; and
