JOB DESCRIPTION

Overview

Manhattan Community Board 3 is seeking a research consultant to complete a new position paper detailing the need for construction of a new public school building at Essex Crossing, a 1.65 million square-foot development on the Lower East Side of Manhattan within Manhattan Community District 3 (CD 3). This paper will be used by the board to advocate for construction of the new school building.

Scope of Work

A previous position paper in 2014 included a planning and demography study in the district and argued for the need for a school at Essex Crossing in light of a projected population shift and increased demand for school seats. As part of the Essex Crossing agreement, the City of New York has set aside land on one of the sites until 2023 for a potential school, although they have not agreed to build one at this time. As demographics have changed since 2014, this paper should re-establish and redefine the need for a school and make recommendations to the Community Board on potential next steps. The paper should build on findings from 2014 that identified lack of accessible facilities, inadequate and old facilities, and school co-location issues, and draw new conclusions based on a broader socioeconomic profile of students and families living in the district, with the primary focus being school equity.

The consultant will:

- research and analyze quantitative data and demographics
- interview stakeholders such as parents and public school education leaders to gather and analyze qualitative information
- periodically attend Health, Seniors, & Human Services / Youth, Education & Human Rights committee meetings during evening hours to present progress reports and receive comment/feedback
- produce an approximately 7-8 page report including appendices that defines and justifies the need for a new school, and a one-two page summary document.

The consultant will report directly to the District Manager.
