



Greetings Neighbors!

Barcade has been open at 6 St. Marks Place since October 2014 and has welcomed visitors of all kinds who wish to experience the arcade dreams of decades past and expand their palettes by sampling the variety of American craft beer we have on draft. During our first year on St. Mark's Place, we have striven to be a positive influence in the community by keeping our front area clean and orderly, by stringently checking IDs to keep under-aged people away from alcohol, and by maintaining a quiet presence on a street that has many residents. Our door staff, who are licensed and experienced, stand at the front of our establishment 7 days a week and keep order, inside as well as outside.

We think our first year on St. Mark's has been a success and we hope to be there for many years to come. However, business is never easy and we need to be able to utilize all of the tools that are available in order to thrive in a tough competitive environment. Due to the ruling of the Community Board (CB4) we have not had the ability to run our business at this location in the same capacity that we do at our 4 other locations - 2 of which are also located in New York City. When we first appeared in front of CB4 in July of 2014, they denied our request for a full liquor license and instead granted us only a beer and wine license (tavern license.) At the time we accepted the decision and were grateful to have some sort of liquor license, even one that was so restricted. We understand the reasons the board hesitated to grant a full liquor license at the time: we were new to the neighborhood and they had no personal experience of how we would conduct our business. However, after a year with a clean record at this location, not to mention a collective 14 years of a clean records at our other locations in New York City, we think it is time for them to reconsider their decision.

Getting approval for a full license will be a challenge and we'd like to appear in front of the board with as many signatures of support from our closest neighbors as possible. You need to let them know that the neighborhood want responsible businesses like **Barcade** to flourish on St. Mark's Place.

To Whom It May Concern,

I'm a journalist and book author in New York City. My new book is called *St. Marks Is Dead: The Many Lives of America's Hippest Street*. I researched the book for several years, and interviewed more than 200 people with a connection to the neighborhood. I grew up on St. Marks Place between First and Second Avenues. My parents have lived there since 1973.

I'm writing in support of Barcade, a bar that I consider a worthy inheritor to 6 St. Marks, which formerly housed the St. Mark's Baths and Mondo Kim's. My interview of the bar's owners when they were first opening up in 2014 was an unexpected delight, as they knew a great deal about the history of the area, and showed remarkable enthusiasm and respect for it. I was thrilled, for example, that in the course of their renovation they uncovered tiles from the original Baths and preserved them.

When my book came out I threw a party for more than 700 people at Cooper Union and then had the after party at Barcade. My guests had a wonderful time drinking beer, eating tater tots, and playing video games. My only complaint was that the bouncer wouldn't let in a 40-year-old friend of mine because he had forgotten his ID at home. While this was an inconvenience to me, it should be reassuring to those charged with deciding whether or not to grant Barcade a liquor license. This is a business that clearly has only the strongest commitment to following rules and to being a responsible St. Marks Place business.
