

Re: 500' area survey for Restaurant Wine License application located at 90 East 10th Street, New York, New York 10003

The applicant will be located approximately mid block on the south side of East 10th Street between Third and Fourth Avenues. East 10th Street between Third and Fourth Avenues is approximately 400'.

There are no churches, schools, synagogues or other places of worship located within 200' of the applied for premises on the same street or avenue nor are there any churches, schools, synagogues or other places of worship within a radius of 300' from the applied for premises.

There are three licenses using an East 10th Street address within 200' of the proposed location. One is an On Premise liquor license and two are Restaurant Wine licenses.


