



Public Congestion Management

The premise of our business is not meant to appeal to the mass audience of nyc millenium dwellers nor are we promoting our establishment as a club or exclusive bar. Our target demographic are established working men & women seeking to enjoy nice handcrafted, original cocktails with ambient music playing in the background to have meaningful conversations with others. We will not tolerate any entrance to drunk, loud, rude individuals; our brand will be built on classy and dress codes are enforced for entrance to the downstairs lounge. Crowds and lines will be handled, hopefully, inside the restaurant portion (upstairs). To gain access to our downstairs lounge (the 10' wide bar) security personnel will begin indoors checking ids and then admit. If our expectations of lines happen to exceed the limit of capacity for upstairs then we will focus our attention to admitting others through management outdoors by guard rails and security through an outside entrance into for the downstairs portion, otherwise anyone can Since our establishment is a few feet from the corner of avenue b, where turning right puts you in front of our entrance vehicular congestion will be prompted towards avenue b rather than a residential street.

Sound Management

- 1. Contacting acoustic consultants
- 2. Installing sound proof insulation in walls ceilings and floors
- 3. Renting out closest apartment (in process)
- 4. Background level music playing on first and ground floor, any djs will be only present in basement level in back isolated room
- 5. Surveying community residents in 1 block radius monthly regarding noise disturbance for first 3 months
- 6. Keeping all wait lines indoor for downstairs lounge area
