Dear Ms. O'Brien:

Community Board 3 has no objection to the new beer and wine application for Kuni's Corporation at 90 East 10th Street, if the signed and notarized stipulations attached are included in the license agreement, that

- 1) it will operate a full service Japanese-style steak restaurant,
- 2) its kitchen will be open and serving food during all hours of operation,
- 3) its hours of operation will be 11:00 A.M. to 12:00 A.M. all days,
- 4) it will not use outdoor space for commercial use,
- 5) it will install soundproofing if necessary and as required by applicable law,
- 6) it will close any front or rear façade doors and windows at 10:00 P.M. every night or when amplified sound is playing, including but not limited to DJs, live music and live nonmusical performances,
- 7) it will play ambient, recorded background music only and will not have DJs, live music, promoted events, scheduled performances or any event at which a cover fee is charged,
- 8) it will not apply for an alteration of its method of operation without first appearing before Community Board 3,
- 9) it will not host pub crawls or party buses,
- 10) it will not have unlimited drink specials with food,
- 11) it will not have happy hour,
- 12) it will insure that there are no wait lines outside,
- 13) it will conspicuously post this stipulation form beside its liquor license within its business, and
- 14) it will provide a telephone number for residents to call with complaints and immediately address any resident complaints.




