#### APPLICANT STATEMENT CONCERNING 200-FOOT RULE

A synagogue in a mixed-use building opened on the street sometime after "The Orange Valve" got the first of a series of full liquor licenses at 355 Bowery in 2003. As a matter of law, premises are exempt from the so-called 200-foot rule when the premise seeking a license had a full liquor license before the place of worship came into existence.

# APPLICANT STATEMENT CONCERNING SECURITY WITHIN AND IN FRONT OF THE PREMISE

The applicants are seeking the same license as the current tenant/license – full liquor for a small, bona fide restaurant with no live music, no outside areas, no dancing, no promoters, no pub crawls, no cover charge. Upon information and belief, the location is not a focal point of police activity, SLA violations or 311 calls. No licensed security will be used but the applicants will give preference in hiring to ATAP-trained servers. Applicants will always have an LLC member or manager present at night who will ensure that management's zero-tolerance policy concerning common ABCL violations do not occur. A responsible person will ensure that there are no waiting lines on the sidewalk and that there is no one milling about.

# APPLICANT'S STATEMENT CONCERNING CERTIFICATE OF OCCPANCY AND/OR LETTER OF NO OBJECTION

The NYC DOB website indicates that while no Certificate of Occupancy exists for 355 Bowery, a Letter of No Objection to an eating and drinking establishment for retail Use Group 6 in 2012. This LNO runs with the building and no new LNO is required for new tenants. The applicant is in the process of obtaining a copy of the LNO from the SELLER and will bring it to the meeting on June 18.






