
RE: MANAGEMENT OF NOISE INSIDE AND OUTSIDE:


The applicant will control noise inside and remind customers to be respectful of neighbors, with a fulltime manager and staff that will be managing the premises at all times.

RE: MANAGEMENT OF VEHICULAR TRAFFIC/CROWDING:

To ensure that this does not become an issue, all staff will be instructed to monitor the sidewalk and curb area to dispel groupings of people and keep the sidewalk clear.
