Quorum was established at 6:45PM and Vice Chair John Weis begins the meeting by announcing one public hearing on tonight's agenda and introduces Lee Compton to present the variance application for a physical cultural establishment. There were no questions.

# **Public Session**

Carl Koster, resident at 1 Columbus Pl., spoke up regarding illegal parking on W58, 59, and 60<sup>th</sup> Streets around Roosevelt Hospital. Doctors who are not members of the hospital are parking for days at a time and are not being ticketed. Chair recommends taking the issue to the Transportation and Planning Committee. Linda Ashley, 44<sup>th</sup> St. Better Block Assoc., complained about Dalton's Bar keeping street furniture out long after November needlessly obstructing pedestrian traffic when cold weather forbids outside seating. She asks what legal standing do they have to do that and should the community stand for such poor neighborly behavior? Also, Ms Ashley agrees with the Business License Committee's recommendation to deny Circus a renewal of a liquor license, another bar that has been a poor neighbor.

Austin Chinn, Clinton resident, agrees with Ms Ashley on Circus denial and it's been an ongoing issue and if the owner does not appear at committee meetings as required, they should be denied. Dalton Bar's winter tables must abide by the six month rule. Regarding the restaurant Amarone and its application for outdoor café tables and chairs, he asks the Board to be careful if it is a variation from their former arrangement. Jay Marcus speaks up about the new variation of adding outside heating elements.

Scott Talbot announces the withdrawal of his application and will be back with another venue later. Robert Trentlyon, resident W 21<sup>st</sup> St. and Board member, announces that green roofs have arrived. He explains the benefits of soil capture of water, reflectivity, a more even flow of water into the sewer system and an original high cost later changing to savings over time. In addition, there should be tax incentives for buildings that propose greening their roofs.

Co-Chair John Weis, noting a light public sign up, asks if any other member of the public wishes to speak: David Glasser, W 23/11<sup>th</sup> Ave Chelsea Apts. resident, warns of the increased size of a neighborhood strip club. Filing at DOB for a 300 person increase shows that the applicant has falsified information and permits have been accepted despite many faults.

## Adoption of Minutes and Tonight's Agenda

Chair J. D. Nolan explains the agenda to be ratified beginning with the TV franchise resolution, item #15 not needing a ULURP vote and item #17 being withdrawn. Members point out that the voting tallies are only attached to the back and M. Treat, Secretary, explains that the recording computer had crashed and that's why discussion and tallies are missing this time. Agenda changes and minutes approved. J.D. then asks **Elected Officials'** representatives to speak:

Hunter Johansson, <u>BP Stringer</u>, announces the deadline for Community Board member applications as January 15 and encourages neighbors to take the available applications. Also, current board members seeking to remain on the Board should submit a one-page reapplication form, also due on January 15. Applications are available on the Borough President's website: <a href="www.mpbo.org">www.mpbo.org</a>. All community board applications pass through a screening panel, which meets AFTER Jan 15. Current strong issues on the BP's agenda are the Moynihan Station and the unfair MTA fair hike. On December 3, Borough President joined with Gov. Spitzer and Major Bloomberg at 7 train extension ground breaking ceremony.

State Assembly Linda Rosenthal's representative, David Weinberg, announces that Ms. Rosenthal will be back in Albany 1/14 Her Office supports the Reproductive Health Act, which shall codify Roe V. Wade in New York State. Also, mass transit should be funded through the budget process.

State Senator Tom Duane, represented by Colin Casey, congratulates the community vision for 11<sup>th</sup> Ave rezoning and speaks of the challenges ahead with affordable housing regarding the Hudson Yards project. City Council Speaker Christine Quinn, represented by Melanie La Rocca, Melanie La Rocca - stressed two items:

1) Speaker's Office held first Aladdin Community Board advisory meeting on December 11. Aladdin is an SRO on W45th St, that has received community complaints; 2) The 11<sup>th</sup> Avenue rezoning public forum was held on Dec 18, and was attended by more than 150 people and speaks about the success of last month's Hudson Yards Advisory Board's open meeting. She especially pointed out the unique and innovative partnership on the 11<sup>th</sup> Ave rezoning co-application with City Planning.

### **District Manager Report**

Robert J. Benfatto, Jr. thanks all for their help on community board business. He announces that the construction company responsible for pouring concrete down the street catch basin (SE corner 40/9<sup>th</sup> Ave) admits responsibility and will begin repair January 15.

#### **Chair Report**

J. D. welcomes all and announces a CB4 seminar about conflict of interest. Two examples: when lobbyists call to influence a vote or when street fairs are being promoted by community groups, what should be a board members response; especially, when it comes to voting? He has requested the conflict of interest experts of the City to come and explain, discuss and answer <u>questions</u> (<u>date and time to be announced</u>). Mr. Nolan further reflected that we are a conservative board by tradition as to conflict of interest, exampling members who volunteer for street fairs and excuse themselves from vote as CB4 members. board member, mentioned that he has 7 years experience working for Conflict of Interest Board, and is available as a resource to help answer conflict of interest questions.

Noticing many citizens have arrived late for public session, he re-opens public comments:

Architect Richard Daily explains and passes out a schematic on Ambarone Restaurant's revised plan for their sidewalk café. A half dozen neighbors speak on behalf of the restaurant's good qualities:

<u>Bradley</u> Office, Rick Tabor ("restaurant contributes to neighborhood"), Sylvia Bailey (favors more sidewalk cafes), T. J. Manix (makes the block safer), Chris Wall ("does not impede pedestrian traffic"), etc.

Sasha Purit, from Borough President's office was invited to speak on Public Access TV and broadcasting CB4 meetings:

This year city will enter into contracts with cable companies. Contracts go through franchise review committee. Borough President has a vote and feels that public access is very important. He wants civic TV channel to broadcast community board meetings, police precinct meetings on public access TV. This would also be a forum for local press discussions. Additionally, feed can be webcast. Anna Hayes Levin asked about MNN. Who are they? Sasha Purit replied that MNN is an independent nonprofit organization that has contract with the city to run these channels. Sasha spoke highly of MNN. Sasha explained that federal law requires that 5% of cable company gross income go to public access. A board member noted that almost all programming is done by amateurs. Sasha says the hope is that channel will be done by paid staff not by amateurs. Would BP consider funding for staffing? Sasha says there will be additional funding. MNN gets grants every year. MNN estimates this will cost \$1 to 1.5 million.

### Clinton/Hell's Kitchen Land Use Committee (C/HKLU)

Lee Compton, CC/HKLU Committee, Explains that this item is a long, complex item regarding proposals to amend NYC Zoning resolutions. These proposals address small lot sizes in NYC. Lee exampled Proposal 5, which allows a developer to put heating equipment on roof, while not contributing to FAR.

Ed Kirkland expressed concerned that proposals do not state clearly who is the party that must approve <u>rooftop greening</u>. Ed feels any increase in bulk should be handled by the City Planning Commission. Ed wants to be sure someone knowledgeable approves <u>such projects</u>.

Christine Berthet expressed concerned about noise on a roof if more equipment is placed on it. Lee said noise is less of a problem on tall buildings but more concern on less tall structure.

A board member would like an exception for solar panels, to allow for a taller structure, if such a structure is a solar panel.

Proposal 4, allows 25% increment in street wall.

Frank Eadie would like to amend language from 5000 to 2500 sq. ft.

Franks amendment does not pass.

Anna Levin urged that the board should take an up or down vote on the proposals as is, because the same proposals are going to other community boards.
