BSA Cal. No. 49-11-BZ re application for a special permit for a PCE at 135 West 20th Street (Barry's Bootcamp)

PUBLIC SESSION

- Carol Demech spoke against any additional development in Chelsea.
- Joanne Downes Coalition of Chelsea Block Association spoke against any additional development in Chelsea.
- Justin Hoy from Save Chelsea stated that they worked hard to achieve the special zoning, and the proposed development goes over it.
- Dave Holowka said that the Brodsky proposed West building proposition is inappropriate.
- Bob Klein states that the 9th Avenue and 15th Street is overcrowded and the residents need more sleep. Non-Chelsea residents come into the area to make money and party. Another hotel will be too much.
- Michael Levine believes Chelsea Market is great but becoming overdone.
- Lesley Doyel of the Council of Chelsea Block Associations met with Greg Struck and have no problem with the proposed restaurant at 408 West 15th St but are against the cabaret license for the lounge in the basement.
- Donna Sherman opening date June 7th, of Phase II and the West 30th Street space. There is a new art installation and they've scheduled activities.
- Devin Moroney Ny Hotel trades council, introduced himself and told the audience to feel free to reach out and talk to him.
- Gregory Struck of the proposed restaurant lounge located at 408 West 15th Street stated they've done outreach to the community, had lots of tours of the property, presented at the 10th Precinct Community Council meeting and the Council of Chelsea Block Associations.
- Rochelle Bass a Real Estate Broker, spoke in favor of Artichoke getting their full

- liquor license, stating it was a value to the community and will only be an enhancement.
- Irana Ivanova from FIT stated that the scaffolding on 7th Avenue should be coming down, and now will be up on the side streets due to Local Law 11.
- Mark Seldon spoke in favor of Gregory Struck's application for 408 West 15th
 Street stating he will be a good operator and that the operation will not be a
 nightclub.
- Elizabeth Finkelstein opposes the new construction on Chelsea Market. The building in 2002, was not included in the city's Gansevoort District but in 2007 listed with the State/National rezoning and would destroy integrity, that it is unnecessary, and damaging to the area.
- Connie Marquez, Deputy Director of Steps to Nonviolence that has programs in public schools for teens to help prevent violence with peer training.
- Allicia Worrell was Peer Leader for Steps in Schools and the program had a major impact on her life, made her feel empowered and realized early experiences of abuse were not her fault.
- Uday Gupta spoke in favor of Artichoke Pizza receiving a full liquor license, lots of families that go there. She likes her gin and tonics.
- Frank Lowe a resident of 19th Street is against the Chelsea Market Development
- John Young of West 15th St. is against the Chelsea Development. Current proposal is against the original vision of the founder in 1998 Irwin Cohen. Other areas will be developed as zoned, why can't the Chelsea Market.

BOARD BUSINESS

John Weis stated Items 6 is 7 and 7 is 6 and that item 12 has been withdrawn.

Elected Official's Reports

Katie Smith--Jerry Nadler's representative—pushing to close the downtown heliport. He's working on the defense authorization bill, reintroducing the equal rights amendment as well. Ed Kirkland asked about the push for the closing of the heliports.

Collin Casey representing Tom Duane – Thanked John Weis for his service as board chair. In addition to the big bills such as marriage equality, he is also working on extend and strengthen the rent laws. Duane supports the bill for victims of child sexual abuse to lengthen the statue of limitations to allow victims to seek retribution against their attackers.

Jeffrrey LeFrancois representing Assembly Member Dick Gottfreid The Gibbons house has an illegal 5th story added by the owner. City was able to get a Nuisance

abatement order against the building. There is talk to bring back commuter tax and congestion pricing. Updates to come. Thanked John Weis for his service.

Jesse Bodine Council Member Gail Brewer thanked John for his service. Gail introduced two new bills going to committee, one regarding tenants rights for repairs and one that will fast track buildings with serious issues.

Melanie LaRocca for Speaker Quinn, thanked John Weis for his service as Chair. Council on Thursday passed a resolution for Penn South, a reolution that has been in the works for 2 years, which should give Penn South more room to embark on a capital improvement project. Introduced Mikaila Miller as the cb 4 liason.

District Manager's Report 127 West 25th Street BRC he had a tour of the facility moving people in July 1st. Presentation from Picture the Homeless looking for volunteers to find empty lots for spaces for shelters. Next board meeting will be July 27th and there will be a public hearing for the board's statement of district needs.
