Dear Commissioner Mendez-Santiago:

Manhattan Community Board No. 4 submits this letter to the City of New York Department for the Aging (DFTA) to support Hudson Guild's proposed development of a Naturally Occurring Retirement Community Supportive Social Services Program (NORC SSP) at the Elliott Chelsea development.

Board 4 is pleased to support a program that helps enhance functioning of its senior residents and ensures their ability to remain contributing, vital members of our community. For the more than 500 seniors living in the Elliott Chelsea development, a NORC program will help develop a community of healthy older adults who will receive enhanced and coordinated health, social and recreational services enabling them to maintain active, independent lives.

Hudson Guild has a long-standing commitment to the residents of Chelsea.¹ For nearly six decades the Guild has provided services specifically targeted to seniors through their senior center in Fulton Community Center. In 2005, Hudson Guild expanded its mental health services for seniors, developing partnerships with St Luke's/Roosevelt Hospital, the New York Housing Authority and Visiting Nurse Service of New York. A new Senior Wellness Access Program (SWAP) addresses the social and health care needs of seniors living in the Elliot Chelsea Houses through case assistance and supportive health services. Within six months this program has impressively provided services to nearly 100 seniors.

The Hudson Guild NORC program proposal seeks to build upon its previous successes by adding comprehensive case management services, enhanced health management services and developing concrete services such as shopping assistance, regular friendly visitation and telephone consultation services. It will also work to assist a growing Chinese-speaking population through cultural integration development efforts.
