**ALTERNATE SIDE PARKING RULES SUSPENSION CALENDAR** The City suspends alternate side parking (ASP) rules on legal and religious holidays. There are no "major legal holidays" this month so only street cleaning rules are suspended, all other regulations remain in effect. There are two (2) dates in April 2013: 4/1 (Mon.) and 4/2 (Tue.).

**BROOKFIELD OFFICE PROPERTIES - CONSTRUCTION OF THEIR WEST DEVELOPMENT** We understand that the current construction activity, which involves heavy rock and concrete removal, creates unwanted noise. Phase I work is being done to build a platform over the rail yard along Ninth Avenue between W. 31<sup>st</sup> and W. 33<sup>rd</sup> Streets. Unfortunately, some of this work can only be done after hours when it won't disrupt train operations by Amtrak, New Jersey Transit and the Long Island Rail Road. This work is estimated to take four months. Beginning now, Brookfield will send out weekly emails on Tuesday detailing the after-hours work schedule for the week ahead.
