| Anita McDonagh | Ms. McDonagh praised the Board for its work throughout the years but then went on to voice her disappointment with the Board for having approved at its November meeting the liquor license application of the Rise Bar, located at 859 9th Avenue. Her main objection was to the extension of closing time from 2 A.M. to 4 A.M. She stated that the bar's claim that it is merely another neighborhood bar is false. Instead, she said, the bar is being run as a cabaret. She asked the Board to look closely at the SLA's 2014 decision on the Rise Bar before the next meeting where a new application by the bar will be taken up. | |
| Neile Weissman | Mr. Weissman spoke of the need for wider bike lanes on the George Washington Bridge, which is the subject of Agenda Item 15. He noted that the \$1.9 GWB re-cabling and restoration project does not provide for widening bike lanes from the current seven feet to the federal USDOT standard. He asked the Board to reaffirm its support of the concept of expanding cycling infrastructure on the GWB to conform to federal standards. | |
| Lisa Wage | Ms. Wager is the Director of Government and Community Relations at the Fashion Institute of Technology. She highlighted the school's sustainability initiatives, including its green roof installation that captures rainwater runoff and the reduction of its carbon dioxide footprint by 43%. She also mentioned the award that students won in a scholastic competition where they used biodegradable waste products to create woven clothing materials. The school offers several courses and workshops that focus on sustainability issues. | |
| Tony Speciale | Mr. Speciale is the artistic director of the Abingdon Theatre Company, which is located at 312 West 36th Street. The company was organized 24 years ago, and has numerous productions to its credit, all of which are noted on their website http://abingdontheatre.org/ . He wanted to reach out to the community for support and to remind people that the company also offers free readings. | |
| Denise Dickens | Ms. Dickens, the creative director of the Abingdon Theatre Company, introduced herself and stood by as Mr. Speciale spoke. | |
| Kasson Colon- Mangia | Mr. Colon-Mangia is an intern with the Historic Districts Council. He announced a free monthly leadership clinic that will be hosted by Councilmember Ben Kallos on Thursday at 244 East 93rd Street. The conversation will include creating landmarks and historic districts, dealing with the Landmarks Commission and DOB and landmarks and zoning issues. | |

Remarks from Elected Officials and Representatives Andrew Mr. Lombardi mentioned the community engagement session that the BP held the previous Lombardi for night where other elected officials and members of the community met to discuss plans for the Port Authority Bus Terminal and other projects affecting the community. BP Brewer is Gale Brewer in discussions with the MTA regarding the planned shutdown of the L Train. She wants to work with the MTA on setting up three community meetings to discuss the impact on the communities around 14th Street. Mr. Lombardi reminded everyone of the February 3rd deadline for Community Board applications and noted that they can be completed online as well as on paper. BP Brewer co-sponsored a bill with Councilmember Chin to reform the process by which deed restrictions are changed. The bill was passed by the City Council on December 6th and provides for more public notice and input regarding deed restrictions, including a public database created by the Dept. of Citywide Administrative Services. BP Brewer also cosponsored a bill that would increase penalties for owners who violate site safety provisions

on construction sites.

Mr. Atterbury announced a Town Hall Meeting hosted by Congressman Nadler that will be held on December 19th about what to expect from the Trump Administration and the new Congress. It will be held at the NYU Kimmel Center from 6 to 8 P.M. The Congressman is a senior member of the House Judiciary Committee and, as such, is pushing for hearings to learn more about potential conflicts of interest of Mr. Trump. He is also working on a possible reform of the Electoral College system. Mr. Atterbury praised the Board for its work on the Port Authority Bus Terminal, also noting that the Congressman and his staff are also working to find new solutions for the new terminal.

Eli Szenez-Strauss for Brad Hoylman

State Senator Hoylman announced legislation this week that would require presidential and vice presidential candidates to submit five years' worth of tax records to the NYS Board of Elections in order to appear on the ballot in New York State. Failure to do so would also bar state electors in the Electoral College from voting for them.

The Senator sent a letter to Governor Cuomo urging him to make his next commissioner appointment to the State Liquor Authority one who is a resident of New York City since most licenses granted by the SLA are for establishments located in the City.

Gabriel Dann-Allel for Richard Gottfried

Ms. Dann-Allel complimented the Board for hosting the community planning meeting on the Port Authority Bus Terminal. She mentioned the expansion of the medical marijuana program by the State Department of Health that incorporated the recommendations of the Assemblyman.

She went on to note that her office has received a great number of calls about the incoming Trump Administration's changes to health care. She said Mr. Gottfried would continue to protect the rights of New Yorkers to quality health care.

Erica Overton for Linda Rosenthal

Ms. Overton noted that the Assembly Member's Airbnb bill was passed into law, allowing the City to go after commercial operators of illegal hotels. She confirmed that her office sent a letter in support of the Board's letter to DOT asking for better markings at the intersection of 12th Avenue and West 46th Street.

Matt Green for Corey Johnson

Councilmember Johnson held two community meetings where the aftermath of the election was discussed, noting that another one will be held at a future date. The Councilmember has allocated funds in the City's FY2017 budget to the nonprofit Association of Community Employment Programs for the Homeless. Known as ACE, the organization provides homeless men and women with job training and experience. MCD4 has three full time ACE

employees who are dedicated to emptying trash bins and picking up litter along 7th, 8th and 9th Avenues. Mr. Green asked for community input on whether the program is working so that decisions on future funding can be made. He also announced a grant opportunity for public schools, neighborhood groups and NYCHA tenants from the Citizens Committee for New York City which awards grants of up to \$3,000 for resident-led groups in the City. Requests must be submitted by January 23rd and can be made online at http://www.citizensnyc.org/grants/neighborhood-grants. Matt reminded everyone of the monthly housing clinics held every month in the local District Office at 224 West 30th Street, with the next one occurring on Tuesday, December 13th at 5:30 P.M.

Eric Holguin for Scott Stringer

The Comptroller issued his annual report entitled *Making the Grade* which tracks the City's yearly actual spending with certified minority- and women-owned business enterprises (M/WBEs). The report covers 31 mayoral agencies plus the Comptroller's Office and assigns letter grades to mark the City's success in meeting spending goals. In FY2016 only 4.8% of City spending went to M/WBEs, down from 5.3% in FY2015. Nearly 80% of M/WBEs did not receive any City funds in FY2016. This resulted in the City getting marked "D+" for the year. The Comptroller has made a number of recommendations for improvement as part of the report, which can be found online at https://comptroller.nyc.gov/reports/making-the-grade/reports/making-the-grade-2016/.
