The Department of City Planning is continuing its extensive public engagement process to develop Vision 2020: The **NEW YORK CITY COMPREHENSIVE WATERFRONT PLAN** with a public meeting on October 12<sup>th</sup>, 2010 at 6:00 p.m. at Rosenthal Pavilion, NYU Kimmel Center for University Life, 60 Washington Square South, 10<sup>th</sup> Floor. The meeting, which follows six months of discussions with community and waterfront stakeholders, will present the plan's goals and draft recommendations and provide an opportunity for public comment. The document contains draft versions of broad citywide policy and programmatic recommendations as well as detailed, site-specific recommendations. Together, these recommendations are proposed to advance the goals of plan, address the pressing issues on the waterfront, and provide a realistic and pragmatic framework for the next 10 years. Please come to the meeting to comment or send in your ideas. The deadline for public comments on the draft recommendations is 5:00 p.m. on Friday, November 12<sup>th</sup>, 2010. The final plan is to be issued by the end of the year.
