1) Thank residents of Kips Bay – especially our own Public Member Liz Gebiner - Kips Bay Neighborhood Alliance and Toni Carlina for working with me and DOT to get the ball rolling on fixing unsafe conditions on Second Avenue at 33rd and 30th Streets. DOT is now looking into changing the traffic lights and pedestrian crossing timing to give pedestrians more time to cross before cars are able to turn into the crosswalk. As part of that effort DOT has announced that 30th Street from Lexington to the FDR will be repaved before the end of May. Congratulations. On Monday evening about 80 people gathered at Baruch College for a visioning session for the Blueway, which is the southern part of our waterfront. It was a successful event, with many members of CB6 there along with residents and representatives from community based organizations. As you know, at 6pm tomorrow evening CB6 is co-hosting a Forum on the Esplanade here at NYU Medical Center downstairs in Auditorium A. State Senator Liz Krueger, Assembly Member Brian Kavanagh and City Council Member Dan Garodnick will address a large number of questions about the project, where it stands and where it is going. Audience members will also be able to ask questions. We expect the discussion to last about an hour. I hope that everyone can attend.
