**Con Edison Reported: Work is continuing on Broadway (bet. 144<sup>th</sup> – 147<sup>th</sup>) St.**

**DCAS Reported:** A Public Hearing will be held to auction City-owned properties located throughout the City of New York. The auction will take place on Wednesday, October 28<sup>th</sup>, 2015, at the Bronx County Courthouse located at 851 Grand Concourse. This will be DCAS' first Real Estate Auction since December 2013.

### **Department of Transportation (DOT) Reported:**

- Department of Transportation is preparing to make a series of changes to Broadway bet. 135<sup>th</sup> and 155<sup>th</sup> Streets. These changes are intended to make the thoroughfare safer for pedestrians while improving the flow of traffic. Assembly Member Denny Farrell and Council Member Mark Levine are co-hosting a Town Hall Meeting on October 27<sup>th</sup>, at 6:30P.M. to discuss DOT proposal for Safety Improvement Project for Broadway between West 135<sup>th</sup> and West 153<sup>rd</sup> Streets.
- **DOT extended bus lanes on 125<sup>th</sup> Street from Lenox Avenue to Morningside Ave.:** - Dedicated lane for buses between Lenox and Morningside Avenues; Drivers may enter bus lanes for quick passenger pick-up/drop-off or right turns only; parking, loading, and bus stops remain at the curb.
- **DOT is conducting a one-year, community-driven planning process to increase safety and mobility for pedestrians and bicyclists traveling across the Harlem River.** The result of the planning process will be a planning document, expected to be released in the Spring of 2016, outlining a series of short and long-term safety improvement projects on city streets and structures connecting Manhattan and the Bronx.

The Harlem River Bridges Access Plan will describe community preferences for increasing access to jobs, schools and recreational amenities on both sides of the river, and will serve as a tool to guide future investment and seek finding for future transportation projects.

## ***Brewer announces Urban Agriculture Symposium, Oct. 14***

***NEW YORK – Borough President Gale A. Brewer announced her office will sponsor a symposium on urban agriculture on October 14, to exchange knowledge, experience, and best practices for growing community-based urban agriculture programs.***

***Brewer has made urban agriculture a focus for her office, releasing *How Our Gardens Grow*, a report on expanding urban gardens, farms, and other agriculture projects that followed nearly six months of surveys, interviews, and site visits. Brewer has also committed \$1 million in capital grants in the coming year for Manhattan public schools to invest in equipment and renovations to establish or expand urban agriculture programs.***

***Urban farming projects run the gamut from hydroponic and aquaculture labs to greenhouses, community gardens, rooftop gardens, and more. Schools, senior centers, community groups, and NYCHA developments across the borough host a range of these programs.***

***Brewer's Urban Agriculture Symposium will be held at the American Museum of Natural History on October 14, 2015. The program will start at 2 p.m. and conclude at 6 p.m.***
