

## May, 2012 District Manager's Report

### Borough Service Cabinet Meeting – Highlights:

**Presentation: Close to Home Legislation**, given by Melvin Alston who reported “Close to Home” is a new juvenile justice initiative to place youth, found by the Family Court to have committed a delinquent act, in or close to their communities to be confined in residential-type settings, or Non-secure Placement (NSP) in the City. Governor Cuomo recently signed the legislation for the implementation plan for NSP and is seeking comments from the community and juvenile justice stakeholders before finalizing and submitting to the State for review and approval. The Public was invited to submit oral or written comments at (2) two hearings:

- **Monday May 7, 2012, 5-8p.m. at the Brooklyn Borough Hall;**
- **Tuesday May 8, 2012, 10a.m. – 1pm, at the Health Bldg.-125 Worth Street**

**Presentation: Summer Youth Employment Program**, given by Imad Olmos, Deputy Director of SYEP, Department of Youth & Community Development who reported the Summer Youth Employment Program (SYEP) provides New York City youth between the ages of 14 and 24 with summer employment and educational opportunities. In 2011 DYCD employed 30,628 participants and placed them at 5,732 worksites. Participants work in a variety of entry-level jobs at government agencies, hospitals, summer camps, nonprofits, small businesses, law firms, museums, sports enterprises, and retail organizations.

The Summer Youth Employment Program is designed to:

- Emphasize real-world labor expectations
- Increase awareness of services offered by local community-based organizations
- Provide opportunities for career instruction, financial literacy training, academic improvement, and social growth

**FDNY reported: Record-Breaking Number of Minorities Took Firefighter Exam** - Fire Commissioner Salvatore J. Cassano and Department of Citywide Administrative Services (DCAS) Commissioner Edna Wells Handy announced on May 8, that 42,161 people took the

2012 firefighter exam - including a record-breaking 19,260 minorities, a 130 percent increase over the previous exam administered in 2007.


### **Sustainable Buildings: Design and Construction in the 21st Century**

Buildings dominate New York City's carbon footprint. The course focuses on Greener Greater Building Plan (PlaNYC) and Zone Green as tools of climate change mitigation and the energy and water efficiency improvements crucial to environmental sustainability. With approximately 75 percent of New York City's carbon emissions coming from energy used in buildings, and projections that buildings will make up 85 percent of all real estate in 2030, NYC is positioned to be the leader in one the most comprehensive efforts to develop best practices in "green" construction and retrofitting. 




