TK on WHLDC

Gave background on the grant making process which will be elucidated by K Boateng at the next meeting

AB asked about payments to TIDES: TK responded that the amount was standard.

JI stated that cutting the grant ceiling was unfair

At this point, there was a quorum and the roll was called and 29 persons were in attendance

To adopt the minutes with any subsequent emendations

WS stated that the location of the reconstructed stairs was in error, AB stated that they were correctly cited. Accepted with one abstention.

St Lukes Hospital: M Scott, G Calliste, T Day

The numbers utilizing the Pediatrics Section dropped as people opted to use the new P&S facility; the space was used to house persons moved from closed hospitals due to the hurricane.

TK stressed the importance of having a local hospital

GMT stated that there must be an additional meeting and dialogue moving toward a solution

Redistricting: AT

We had lobbied to have the District 7 lines be coterminous with those of CB9n but much of Convent Av was cut out and attached to Central Harlem. Now 7 goes south to include Park West Village. The political heavyweights made the decision. The lines must now go to the **Justice** Dept for clearance. A Fed suit appears unlikely
