- Medallion Sales (TLC)—Written comments must be submitted by April 23.
- Rules Relating to Carbon Monoxide Detecting Devices and Systems in Multiple Dwellings and Private Dwellings (HPD)—Written comments must be submitted by April 24.
- Horsepower Specifications for Hybrid Electric Taxicabs (TLC)—Written comments must be submitted by May 10.
- Sale of Product (Agency Surplus) by City Agencies (DCAS)—Written comments must be submitted by May 4.
