Contains Criminal Possession of a Controlled Substance, Criminal Sale of Controlled Substance, Criminal Sale Controlled Substance on School Grounds, Criminal Injection Narcotic Drug, Criminally Using Drug Paraphernalia, Criminal Possession of Precursors of Controlled Substance, Criminal Sale of Prescription for Controlled Substance, Criminal Possession of Marijuana, and Criminal Sale of Marijuana
- (2) Contains Criminal Possession of Weapon, Criminal Use of Firearm, Manufacture Transport Disposition and Defacement of Weapons, Criminal Sale of a Firearm, Criminal Sale of Firearm with Aid of Minor, Criminal Sale of Firearm to a Minor,
- (3) Contains Criminal Sexual Act, Sexual Abuse, Persistent Sexual Abuse, Agg. Sexual Abuse, Course of Sexual Conduct Against a Child, Female Genital Mutilation, Facilitate Sexual Offense with Controlled Substance, Obscenity, Incest, and Disseminating Indecent Materials to Minors
- (4) Contains primarily the Penal Law offenses of Criminal Contempt 1, Reckless Endangerment 1 and Aggravated Harassment 1 as well as Other State Law (Tax Law, ABC, etc.)
