# NEW YORK CITY AND ITS FINANCING ENTITIES ANNOUNCE THE SELECTION OF FINANCIAL, PRICING, AND SWAP ADVISORS

The Mayor's Office of Management and Budget, the City Comptroller's Office, the New York City Municipal Water Finance Authority and four of the City's financing entities announced today the selection of financial advisors, pricing advisors and swap advisors.

#### New York City General Obligation Bonds

The Mayor's Office of Management and Budget and the City Comptroller's Office conducted an RFP process for financial advisors, pricing advisors, and for a swap advisor for the City of New York General Obligation ("GO") bonds.
