Under TLC Rules You Can Plead Guilty & Pay a Lower Fine

If you received a summons from the Taxi and Limousine Commission (TLC), you may be able to plead guilty to the summons on or before the scheduled hearing date on your summons.

If your summons states *personal appearance required* you may not plead guilty before the hearing date.

<ul style="list-style-type: none">• If your summons is dismissed at the hearing you will not have to pay a fine.• If you are found guilty after the hearing you may pay a higher fine.	<ul style="list-style-type: none">• Check the back of this flyer to see if your summons qualifies.• To plead guilty, come to the hearing location listed on your summons on or before the hearing date.• You will not have a hearing if you plead guilty and pay the penalty.• If you plead guilty to the summons you will not be allowed to appeal.
