Project Location: The proposed rezoning would encompass the entire block bounded by 138th Street, 37th Avenue, 39th Avenue, and Union Street (Block 4978, Lots 25 and 46), located in Queens Community District 7. The proposed Flushing Commons project would be constructed on a portion of Lot 25 (“project site”). The remainder of the rezoning area is occupied by Macedonia African Methodist Episcopal (AME) Church (Lot 46), as well as a portion of the municipal parking lot (Lot 25) not included in the Flushing Commons project site.
