## NYC VCP Cleanup Plan Remedial Activities to Begin

The New York City Office of Environmental Remediation (OER) is providing this Fact Sheet pursuant to the New York City Voluntary Cleanup Program (VCP). OER has approved the Remedial Action Work Plan (RAWP) submitted by Mc Sam Hotel Group, LLC for 337 West 36th Street in the Midtown West section of Manhattan, New York (Block 760, Lot 20). The remedial work will begin in March 2016. The RAWP can be reviewed electronically or in person at the document repositories identified in the box at left.

### Site Description:

The 2,500 square-foot site is currently consists of a full cellar, commercial warehouse space on the first floor, and residential space on the second through fourth floors. The proposed development is to construct a 24 story hotel with a 500 square foot rear yard in the northeast portion of the property.

### Summary of the Remedy:

The remedial action for 337 West 36th Street is a Track 4 Site Specific SCOs Use cleanup. The specific elements of the proposed remedial action include:

- Preparation of a Community Protection Statement and performance of all required NYC VCP citizen participation activities according to an approved Citizen Participation Plan;
- Performance of a Community Air Monitoring Program for particulates and volatile organic carbon compounds;
- Establishment of Track 4 Site-Specific Soil Cleanup Objectives (SCOs); Excavation and removal of soil/fill in excess of SCOs;
- Transportation and off-site disposal of all soil/fill material at permitted facilities in accordance with applicable laws and regulations;
- Collection and analysis of end-point samples to determine if the remedy attains Track 4 SCOs;
- Construction and maintenance of an engineered composite cover and installation of a vapor barrier system beneath the building foundation slab;
- Installation of a vapor barrier/waterproofing system beneath the building slab and outside foundation sidewalls below grade;
- Submission of an approved Site Management Plan (SMP) in the Remedial Action Report (RAR) for long-term management of residual historic fill; and
- Submission of a RAR that describes the remedial activities certifies that the remedial requirements have been achieved, defines the Site boundaries, and describes all engineering and institutional controls to be implemented at the Site.

Cleanup activities are scheduled to begin in March 2016 and are expected take approximately three months to complete.

**Next Steps:** After the enrollee completes the remedial work, a RAR will be prepared and submitted to OER. The RAR will describe the cleanup activities and certify that all cleanup requirements were met. Once the RAR is approved, OER will issue a Notice of Completion, a City liability release, and a New York City Green Property Certificate. OER will then issue a fact sheet announcing the completion of the remedial action and identify all engineering and institutional controls to be used at the Site.


