### Arsenal Gallery Debuts "The Land Art Generator Initiative: Freshkills Park"

On Wednesday, June 26, NYC Parks announced "The Land Art Generator Initiative (LAGI): Freshkills Park," an exhibition of the top 25 designs selected from the 2012 design competition. LAGI 2012 challenged artists, architects, designers, engineers, and landscape architects to design site-specific public installations that harness renewable energy and distribute it into the utility grid.

When park construction is complete in 2040, the 2,200-acre Freshkills Park will be nearly three times the size of Central Park and will be the largest new park in New York City in more than 100 years. The transformation of what was formerly the world's largest landfill into a scenic and cultural destination is an example of natural landscape restoration outlined in PlaNYC. In addition to providing a wide range of recreational opportunities, the park's design, ecological restoration, and cultural programming will emphasize environmental sustainability by supporting the diverse wildlife, and promoting environmental research.

The exhibition will be on display through August 30 at the Arsenal Gallery in Central Park.

### NYC DOT announces the return of Summer Streets and Weekend Walks

On Wednesday, July 3, DOT Commissioner Janette Sadik-Khan announced the return of Summer Streets — the sixth annual event that opens nearly seven miles of car-free streets in Manhattan from the Brooklyn Bridge to Central Park. This year's Summer Streets features "Voice Tunnel," an interactive art installation in the Park Avenue Tunnel by Rafael Lozano-Hemmer, a 165-foot-long zip line, a 25-foot-tall rock climbing wall and City Picnic area, and new additions such as a mini-golf course and misting station. Summer Streets will be held the first three Saturdays in August from 7 a.m. to 1 p.m.

DOT is also partnering with community groups in every borough to present Weekend Walks, temporary pedestrian streets in commercial areas to expand access to local businesses and cultural institutions, and to promote healthy, safe, and fun recreation through music performances, arts and crafts classes, and programming for kids.

# DEP Launches Educational Initiative to Improve Cleanliness and Aesthetics of City Beaches

On Tuesday, July 9, DEP Commissioner Carter Strickland, along with community and federal partners, launched "Clean Streets = Clean Beaches," a public information campaign and beach clean-up program to improve the cleanliness and aesthetics of New York City beaches by reducing littering. This summer, "Clean Streets = Clean Beaches" posters will appear at area beaches and on approximately 2,000 Department of Sanitation vehicles citywide. DEP will also be giving away thousands of reusable tote bags at city beaches throughout the summer that people can use instead of disposable plastic bags that can end up on the streets. In addition, DEP will join with the Department of Youth and Community Development to clean waterfront properties affected by Hurricane Sandy in July and August.

## **Center for New York City Neighborhoods Announces 100 Homes Saved From Foreclosure**

On Wednesday, July 10, the Center for New York City Neighborhoods (CNYCN) Executive Director Christie Peale and NYC Department of Housing Preservation and Development (HPD) Commissioner Mathew Wambua announced that 100 homeowners in mortgage distress will receive foreclosure prevention loans through the City's Mortgage Assistance Program (MAP), which provides loans of up to \$25,000 to homeowners at risk of foreclosure. HPD, along with private donations that include a grant from the Ford Foundation, provided funding.

To date, MAP spent more than \$2 million to create and sustain affordable homeownership in New York City. On average, MAP loans have helped to reduce homeowners' monthly mortgage payments from 42 percent of their monthly gross income to 31 percent. In addition to the 100 loans already funded, CNYCN approved 48 MAP applications that will result in an additional \$940,000 in funding.
